MONTHLY MEETING - 27th. JANUARY, 1987:-

The meeting commenced at 1415 hours with President Alf Carpenter in the chair and 57 Members and Visitors in attendance.

The Minutes of the previous Monthly Meeting (November, 1986) were read and adopted. There was no Business Arising therefrom.

President Alf also reported on his attend ance at Lismore and Newcastle Christmas "Get Togethers"and his visit to Nelson's Bay with John Hawkins,Pat Bruty,to arrange with Chic Sleeman the details of our forthcoming Re-union there. Accommodation Proforma,etc.,is included with this issue of "W.O.G." and members are asked to complete and return it to Chic Sleeman promptly.

Allen Lindsay outlined a proposed programme for our 50th.Anniversary but details will be promulgated when all is finalised and we are closer to the "D" Day date.Lieut-Col. Elwyn Andrews (Son of our own Roy Andrews) is now our contact with 2 Military Div. and after being re-introduced to our members, many of whom he had met before as a humble Captain, he promised to assist with our Anniversary Celebrations from the Army aspect - visits to Victoria Barracks and to the original 2/4 8n.area at Ingleburn (for a 8.8.Q.) for example. Allen advised that our formal dinner will be held at the very modernised R.A.S. Showground Complex (modernised by Architects who happen to be the sons of our own Cec Chrystal and Associate Member Gordon Maitland) where many of us were accommodated in sheep pens, etc., and which is presently under the control of OUR (Major-Gen.) Gordon Maitland. There will be buses from and to the City and Showground by arrangement with Johnny Ringrose, whom Allen has appointed Bussing Officer. This is another role Johnny has to play in our affairs since the Editor has already nominated him as Official Name-Taker at funcions excluding Funerals, where Harry Wright is the formal Recorder.

Alex Arnott suggested that we invite Sydneybased members of 2/11 Bn.to join us on Anzac Day and President Alf agreed to write formally to their Association to that effect, pointing out that they are, in any case, eligible to join our Association.

Laurie Waterhouse extended his personal congratulations to the new Editor on the production of January "W.O.G."

CORRESPONDENCE "IN":-

From VIC FORBES who raises the question of the disposal of deceased members' war medals when there is no kin to whom those medals can be bequeathed or when the member wished to dedicate them elsewhere. In the case of members who might desire to leave their medals to our Association. VIC has suggested that we acquire a Medal Cabinet (similar to a Bowlers' Badge Board and either made for, or purchased by, the Association to a size and specification determined by the Committee) which would be hung or otherwise located in the Anzac Room at the Gallipoli Memorial Club, with approval from Secretary-Manager HARRY GJEDSTED, the ex-soldiers' Army Number, Rank and Names being notated under the medals.

If this project is to proceed, its effectiveness will depend upon the number of medals we are likely to receive from our members and we now seek a reaction to the proposal - in writing, please.

VIC has offered to donate \$100.00 towards the cost of a cabinet and for the moment the Committee has asked that he leave the matter in suspense until response from members enables an assessment to be made.

Norm MacIntyre answered the Last Call on the night of 27th. January and two nephews, Don and Athol MacIntyre, recorded his passing by means of the following Notice: "The relatives and friends of Mr. Norman Struan MacIntyre, NX4050-2/4 Aust.Inf.Bn.and 21 Cathie Street,Petrie Terrace, are advised that he passed away on Tuesday. They are requested to raise a glass to his memory. There will be no funeral service as his body has been willed to Queensland University".

The following Eulogy was delivered by a Minister of Religion at Buranda (Q'land) ^cuneral Parlour: (Contd.)

VALE - Norman Struan MACINTYRE (Contd.):- .

"Norm was born at Parramatta, N.S.W., in 1918 and was educated at Merrylands Public and Parramatta Intermediate High Schools. He learned typing & shorthand and became Secretary to the General Manager of Clyde Engineering Works at Granville. He worked through the depression years and was active in cricket, tennis and football. In 1937 he accepted a position at the Commonwealth Rolling Mills at Port Kembla and remained in that position until 1939.

He enlisted at the outbreak of war, went into training at Ingleburn and sailed with 2/4 Bn.on the first troop-ship convoy to the Middle East. He served in the Intelligence Section of the Bn.throughout the war,or at Brigade H.Q., and attained the rank of Staff Sergeant. He was in the first thrust into the Western Desert and saw service in Greece and Crete and Syria before the Bn. returned to Australia and finally New Guinea.

Norm was awarded an M.I.D. and was one of only three Australians to receive the U.S.S.R. award of the Order of the Patriotic War, 1st. Class.

At the end of the war, Norm went to Singapore on SS"Duntroon". There, by a small miracle the Grace of God, he found the grave of h brother, Lieut. Athol MacIntyre, who was killed in action in the last days of fighting before Singapore fell.

On discharge, he joined his brother, Don, in Dairy Farming and later tried Pig Farming. His last venture was a cattle property at Tabulam on the Clarence River. He said this was the happiest time in his life, but his health began to fail and he moved to Brisbane, taking a job with Rheem. He developed Emphysema which, in the end, turned to Pneumonia.

Norm never married. He bore the scars of his army mates held him in high esteem.

Norm was small of stature but big of her- . He stood up for the things he believed . ne stood up for the things he believed . & so earned the respect of all. May he rest in peace".

The Memorial Service was attended by Bruce Cork, Jack Hughes, Norm Everson, Wally McKenzie, Gordon Bladen, Frank Gattenhoff, Laurie McCosker and Vera Provians.

After the Service, our members and Norm's nephew retired to Cooparoo RSL Club where they drank to Norm's memory beneath a 2/4 Bn.plague which had been presented to that club by our late Tom Provious.
