ANNUAL CHURCH PARADE - ASSOCIATION OF 4th.INFANTRY BATTALIONS:-

The 17th.Annual Service in the 16 year history of the above Church Parades was conducted by the Rev.Angus Tipping in St.Anne's Anglican Church at Strethfield/Homebush on Sunday,21st.June,an occasion rendered somewhat sad by the knowledge that it was the last time this Service would be in the control of Angus Tipping because of an early retirement decision.

For the customary short march to the church, the parade assembled at nearby Heresford Road West Municipal Park under the auspices of 4 Bn. The Royal N.S.W. Regt. and before the march began we (the "oldies") witnessed the ceremonial investiture of two members of the Unit with Long Service Medals. As this Battalion will shortly be amalgamated with 3 Bn.under the new identity of 4th./3rd.Bn.The Royal N.S.W. Regt., it was fitting that on this occasion in its own original right the Unit should parade with full ceremony its Queen's and Regimental Colours and carry them on the march and into the church to be received by Rev. Tipping.

At the conclusion of the Service a very delightful afternoon tea was provided by ladies of the church, in the crypt, where Vin Hallinan farewelled Angus Tipping and presented him with a gift and a badge of the Association of 4th.Infantry Battal-

LIKE FATHER - LIKE SON-IN-LAW:-

An editor needs to be something of a detective and in that capacity I have discovered a letter with an obscured date but written in 1918, and another one dated 5th.August, 1918, sent by the Officer i/c Base Records at Victoria Barracks, Melbourne, to a Mrs. A. Gearside of 55 Henderson Road,Alexandria,N.S.W.,about her son, No. 5102 Private J.T.L. Gearside of the 4th. Battalion, A.I.F., who at one time during www was Runner to Captain (later Lieutenant− General Sir Iven) Mackay. The first letter reads:"I have much pleasure in forwarding hereunder copy of extract from Second Supplement No.30424 to the LONDON GAZETTE, dated 11th.December, 1917, relating to the conspicuous services rendered by the undermentioned member of the Australian Imperial Force:

AWARDED THE MILITARY MEDAL

'HIS MAJESTY THE KING has been graciously pleased to approve of the award of the Military Medal for bravery in the field to the undermentioned .. No.5102 Private J.T.L.Gearside'. The above has been promulgated in COMMONWEAL—TH of AUSTRALIA GAZETTE No.66, dated 2nd.May, 1918 ... Yours faithfully, etc."

Abbreviated, the second letter confirms the award to Pvt.J.T.L.Gearside of a Bar to the Military Medal.

Further research revealed the following citations, which I have abbreviated to some extent:

(1) "East of YPRES on 22nd.September,1917,after having worked continuously for the previous 24 hours carrying messages in the shell area,though very fatigued he readily and (Contd. on Page 7)

LIKE FATHER - LIKE SON-IN-LAW (Contd.):cheerfully conveyed a message from the support line positions through heavy shell fire to the Battalion Transport lines,a distance of approximately 9 miles."

(2) "For conspicuous bravery and devotion to duty at BROODSEIRDE RIDGE east of YPRES on 4th.October, 1917, as Battalion runner he conveyed a message to the front line and was returning through heavy shell fire when a shell burst and badly wounded him in the hand. Though very faint and sick with the pain of the wound he struggled on and brought back reliable information at a critical time, awarded Bar to Military Medal".

So much for the LIKE FATHER aspect of my story! What about the LIKE SON-IN-LAW aspect?? The answer can be found, and read, on Page 307 of WHITE over GREEN, the Official War History of 2/4th.Australian Infantry Battalian. To explain - the 4th.Bn.Private Gearside.MM & Bar, later had a daughter christened Nina and when she grew up she married a 2/4th.8n.Private Robert David Fergusson,MM (incidentally, Bob's surname is incorrectly spelt "Ferguson" in the War History - Ed.). WEWAK AFTER THE SURRENDER - PART 2:-

New Year's Eve was approaching fast and the troops had been saving some of their beer ration to celebrate the occasion. I also knew that a quantity of "jungle juice" was quietly fermenting in a hidden container. This was an evil-looking purple mixture that tested the courage of those who were game enough to drink the concection.

As our departure from Wewak appeared to be imminent,we decided that it would be a good idea to "knock over" our hoard of grog, and that we did. Well, it turned out to be a night to remember as, during our celebrations, we completely demolished the fence surrounding the parade ground.

The following morning on parade, after a tongue lashing,all those who had taken part in the wanton destruction were ordered to take"one step forward". To the best of my recollection. everyone did just that and then we were told in no uncertain manner to rebuild the fence, even if it took all week. Everyone got cracking and we finished the job that day.Nothing more was ever said about that incident. THE TRANSFER TO RABAUL:

On 4th. January, 1946, we went aboard "S.S. Duntroon" and, much to our dismay, sailed for Rabaul, New Britain. It was disappointing to learn that we were not homeward bound after all.

WEWAK AFTER THE SURRENDER (Contd.):There was an overnight stop at Finschhafen, where some Americans were still stationed, and we reached our destination after a voyage of a week's duration.

The ship anchored in Rabaul harbour on the evening of the 10th and there was some confusion as to whether we were to have our evening meal on board. Eventually we disembarked and were allocated to our new Units. Then we were fed. On 11th January, 1946, I became a member of the 31/51st.Infantry Battalion, 11th Brigade, which had been in action on Bougainville.

On our first parade the C.O. gave a brief speech about the role played by the 31/51st. in the war and ordered the removal of our 2/4th.Colour Patches. This directive did nothing for our already low morale but to protest would have been useless. The "White over Green" Colour Patch was not to be seen again until, on board ship in July, we finally sailed for home.

We were now in a camp at Talili Bay, the scene of an enemy landing when Rabaul was invaded soon efter Japan entered the war. It was not too bad; luckily, there was the surf in which to cool off, as the sun seemed to be fiercer than at Wewak. A recreation hut equipped with table tennis facilities, and an open-air picture theatre, were nearby and both made life more bearable.

One day there was a call for volunteers to join the B.C.O.F. in Japan and a few of the men stepped forward, to be flown out the following morning. I had mixed feelings about this opportunity to see Japan but decided that it was more important for me to return home as soon as possible and resume my carser in civilian life.

We were soon assigned to the various Japanese P.O.W. compounds to commence guard duties. Each compound contained about 10,000 men and there were between 100,000 and 110,000 prisoners in the Rabaul area. We would move about from one to the other and were given rest periods back at our camp between the guard duties.

One compound to which I was assigned was situated in close proximity to Rabaul Harbour with its backdrop of volcanoes. While patrolling around the fence in the early hours of one morning,on my way to a Bren gun tower,I almost stepped on a long yellow-spotted snake which was wriggling across the track. Fortunately,I was carrying a torch, otherwise there would have been a nasty (Contd.next column)

altercation in the dark. Two courses of action were open to me; either blast the living
daylights out of it with my Owen gun,or remain motionless and hope it would just continue on its way. I chose the latter, with success, in preference to waking up the entire compound - which would most certainly have resulted in pandemonium.

The weather was very hot and humid and,unfortunately, we were now too far away from Talili Bay to go surfing, which would have kept the heat rashes and pimples under control. I was reporting daily to the R.A.P. to be swabbed over with lotion or methylated spirits. I find that this treatment is still necessary during the months of January and February in Sydney. On the bright side, there was quite a good O.R.'s Club nearby which we patronised regularly. The club was equipped with the usual recreational facilities and with constant playing some of the boys became very proficient at table tennis. Not far away there was a barber shop with a young chinese girl in attendance (and we had to get landed with Mick No-Change O'Regan - might have been better if he had been No Chang O'Legan - Ed.). Rabaul was certainly more civilised than Wewak.

The Rabaul Racecourse was in the immediate vicinity and the Inaugural Meeting of the Club took place on 26th.January, 1946. I still a copy of the roneod programme which lis. Brigadier R.E.Winning D.B.E. as the Rabaul Army Race Club's President. Maybe this was Lieutenant-Colonel "Bob" Winning listed in our War History Nominal Roll as NX44 Winning, R.E.? (I believe it was - Ed.). The final meeting of the club was held on 20th.April, 1946. Our period of guard duty in this area eventually came to an end and we were transferred to another compound which was situated down the coast beyond Talili Bay. This one held about 10,000 Japs and was guarded by 28 men,divided into four sections each of seven. Each section manned a Bren gun tower and mounted guard at the gate on each corner of the compound. During the day, Jap work parties drove out in their trucks to cultivate their vegetable gardens in the surrounding area. When it become necessary for produce to be transported (the area, one of us acted as an escort, armed with an Owen gun and ammunition. However, the prisoners were, in the main, docile and there were never any anxious moments during these trips. Some of their Officers spoke English & even a little trading occurred with the exchange of tobacco for hand-painted silk handkerchiefs or other items of interest.
