WHEREAS, the SEQR Regulations declare Type II Actions to be actions that have no significant impact on the environment and require no further review under SEQRA; and

WHEREAS, the Board of Education, of the Valley Stream Union Free School District #24, as the only involved agency, has examined all

information related to the capital improvement project and has determined that the capital improvement project for the District-wide Backflow Prevention project at the William L. Buck, Robert W. Carbonaro, and Brooklyn Avenue Elementary Schools is classified as a Type II Action pursuant to Section 617.5 (2) of the SEQRA Regulations;
