## **VII. LIST OF ITEMS FOR ACTION:**

### **A. PERSONNEL**

1. WHEREAS, Ms. Laura Peterson is currently employed by the District in the tenured position of Director of Special Education; and

WHEREAS, the Board of Education intends to abolish the Director position and appoint Laura Peterson to a newly created position of Director of Pupil Services.

NOW, THEREFORE, BE IT RESOLVED THAT the Board of Education abolishes the position of Director of Special Education effective July 1, 2019; and

BE IT FURTHER RESOLVED THAT the Board of Education creates the position of Director of Pupil Services; and

BE IT FURTHER RESOLVED THAT Laura Peterson, is hereby appointed to the position Director of Pupil Services effective July 1, 2019 and

BE IT RESOLVED THAT in connection with the foregoing, the Board of Education has determined that fifty (50%) or more of the duties of Ms. Peterson's current position of Director of Special Education is included within the job duties of the position of Director of Pupil Services. Therefore, pursuant to the Education Law, Ms. Peterson shall carry with her to the new position of Director of Pupil Services all the tenure and seniority rights that she acquired in the position of Director of Special Education; and

BE IT FURTHER RESOLVED THAT the Board President is authorized to execute a new salary and benefits agreement for the 2019-2020 school year with Ms. Peterson for the newly created position of Director of Pupil Services, which shall provide for the same salary and fringe benefits she received in the position of Director of Special Education.

2. BE IT RESOLVED, upon the recommendation of the Superintendent of Schools, the Board of Education hereby accepts the resignation of Daniel Bajramovic, as a cleaner in the district, effective close of business July 9, 2019.

3. BE IT RESOLVED, upon the recommendation of the Superintendent of Schools, the Board of Education hereby approves the following to be assigned as custodial summer helpers, effective July 9, 2019, at the appropriate rate/scale of

pay, according to the salary set by the Board of Education at the July 8, 2019 Reorganization Meeting: Jalen Smith.

4. BE IT RESOLVED that the Board of Education of the Valley Stream Union Free School District Twenty-Four (hereinafter referred to as the “Board of Education”) having reviewed in executive session a Side Letter Agreement between the Valley Stream Union Free School District Twenty-Four and the Valley Stream Teachers Association Educational Office Personnel (EOP) Unit (hereinafter referred to as the “Association”), hereby approves the terms of said Side Letter Agreement;

BE IT FURTHER RESOLVED by the Board of Education that the Board President is herewith authorized to execute said Side Letter Agreement between the Valley Stream Union Free School District Twenty-Four and the Association on behalf of the Board of Education.
