## 1. DETERMINATION OF QUORUM & CALL TO ORDER -

Having a quorum, the Annual Reorganization Meeting was called to order at 5:31 pm by the School District Attorney at the William L. Buck School. Motion to enter Executive Session at 5:31 pm was made by Trustee Maier and seconded Trustee Nunez to discuss Personnel and Contractual Obligations.

Motion to exit Executive Session at 8:02 pm by Trustee Maier and seconded by Trustee Nunez.

The Annual Reorganization Meeting was reconvened at 8:07 pm, at the William L. Buck School by the District Clerk.

## 2. SALUTE TO THE FLAG

The Attorney administered the Oath of Office to the newly elected Trustee: Alisa Clark. The term will be from July 1, 2024 - June 30, 2027.

3. The Attorney administered the Oath of Office to the Superintendent of Schools, Dr. Unal Karakas.

4. The Attorney called for nominations for the Office of President for 2024-2025.

Trustee Maier nominated Armando Hernandez for Office of President and seconded by Trustee Wheeler.

5. Motion made by Trustee Maier and seconded by Trustee Wheeler that Armando Hernandez, to be President of the Board of Education of the district for the school year 2024-2025. **6-0 motion carried.**

per hour for legal interns, and \$145.00 per hour for paralegals for all matters not included in retainer agreement.

57.
