2. BE IT RESOLVED, upon the recommendation of the Superintendent of Schools, the Board hereby approves the agreement between the District and Lynbrook School District for Health Services for students for the 2018-2019

school year and authorizes the Board President to execute the Agreement on behalf of the Board of Education at the rate of \$1,042.65 per student; totaling \$12,511.80.

- **3. BE IT RESOLVED,** upon the recommendation of the Superintendent of Schools, the Board hereby approves the agreement between the District and Great Neck UFSD for Health Services for students for the 2018-2019 school year and authorizes the Board President to execute the Agreement on behalf of the Board of Education at the rate of \$1,094.41 per student; totaling \$2,188.82.

- 7. WHEREAS, the District receives its water supply for the Brooklyn Avenue School, Robert W. Carbonaro School and William L. Buck School from New York American Water;
- WHEREAS, the District received notices from New York American Water requiring action by the District to comply with New York American Water's Cross

Connection and Backflow Prevention program implemented pursuant to New York State Department of Health Article VI, Nassau County Public Health Ordinance at the Brooklyn Avenue School, Robert W. Carbonaro School and William L. Buck School locations;

WHEREAS, an investigation of the District's facilities and inspection of the water flow by the District's Architect, H2M architects + engineers ("H2M") at the Brooklyn Avenue, Robert W. Carbonaro and William L. Buck Schools, revealed that the following immediate action is required to comply with the notices received from New York American Water: installation and testing of backflow prevention devices at the Brooklyn Avenue School, Robert W. Carbonaro School and William L. Buck School locations at an estimated cost of \$166,155.00;

WHEREAS, based upon information provided to the Board of Education through H2M and District Administration, the Board of Education has determined that the conditions referenced in the notices received from New York American Water and subsequently investigated by H2M require immediate action to preserve the integrity of the District's facilities, the health, safety and welfare of the students and staff in the buildings and public property; and

NOW, THEREFORE, BE IT RESOLVED, that the Board of Education hereby declares the above-described conditions at the Brooklyn Avenue, Robert W. Carbonaro and William L. Buck Schools to be an emergency that requires immediate action by the District; and

BE IT FURTHER RESOLVED that the Board of Education authorizes the installation and testing of backflow prevention devices at the Brooklyn Avenue School, Robert W. Carbonaro School and William L. Buck School locations to comply with New York American Water's Cross Connection and Backflow Prevention program implemented pursuant to New York State Department of Health Article VI, Nassau County Public Health Ordinance as an ordinary contingent expense; and,

BE IT FURTHER RESOLVED that the Board of Education authorizes the Superintendent of Schools, his designee and other authorized representatives of the District to take all necessary steps to comply with the notices received from New

York American Water, including the preparation of plans and submissions to the Department of Health, New York American Water and State Education Department, and to install and test the backflow prevention devices at each of the above-referenced locations.
