# BOARD OF EDUCATION VALLEY STREAM SCHOOL DISTRICT 24

BUSINESS MEETING 5:30 PM

WILLIAM L. BUCK SCHOOL March 25, 2020

The Business Meeting was called to order at 5:34 PM, at the William L. Buck School, by President Hernandez.

Dr. Sturz stated that the Administrators are meeting remotely daily with each other and with staff to keep the communication flowing and to maintain the running of the district. Everyone is pitching in together.

The Distance Learning initiative has been a success, with credit given to Dr. Conte, Mark Onorato and the Principals, the ongoing commitment of our Teachers and Tech Team, and the Parents providing support at home.

WHEREAS, a number of public school districts in Nassau County wish to jointly solicit proposals, together with the Nassau Board of Cooperative Educational Services ("BOCES") for pupil transportation services for the 2020-21 school year (and any renewal period) in accordance with the applicable provisions of General Municipal Law;

WHEREAS, the public school districts and the BOCES have agreed to form a Cooperative (the "Cooperative") for this purpose;

WHEREAS, the Valley Stream #24School District is desirous of participating in the Cooperative for joint solicitation of proposals for pupil transportation services as authorized by General Municipal Law, Section 119-0 in accordance with the terms and conditions of the Inter-Municipal Cooperative Transportation Agreement attached hereto;

NOW THEREFORE BE IT RESOLVED, that the Board of Education authorizes the School District to participate in the Cooperative; and

BE IT FURTHER RESOLVED, that the Board of Education hereby approves the Inter-Municipal Cooperative Transportation Agreement (Recitals) attached hereto and authorizes the Board President to execute the Agreement on behalf of the Board of Education.

3. BE IT RESOLVED that the Board of Education hereby authorizes the disposal and sale of the Kimball Whitney spinet light oak upright piano from the Brooklyn Avenue School.
