2. Upon the recommendation of the Superintendent, that the Board of Education accepts a donation from Lions Club International and their Lions Lend an Ear Foundation, of face masks with clear front panels for each of the Speech Language Pathologists in our District.

- **3.** Upon the recommendation of the Superintendent of Schools, the Board of Education hereby authorizes the District to enter into an agreement with Dr. Caryl Oris for related services for the 2020 2021 school year and further authorizes the President of the Board of Education to execute the necessary documents to effectuate said Agreement.
- **4. WHEREAS**, the District embarked upon a District-Wide Energy Project ("Energy Project") in or about May 2, 2016 when the District issued a Request for Proposals for the Energy Project; and,

WHEREAS, the Engineer of Record for the Energy Project is ECG Engineering, P.C. ("ECG"); and,

WHEREAS, under Section 179D of the Internal Revenue Code ("IRC"), eligible businesses entitled to tax benefits under Section 179D include **engineers** that have performed energy-efficient work on new government buildings or renovations/retrofits of existing government buildings; and,

WHEREAS, ECG may be eligible for tax benefits that may arise from the Energy Project pursuant to Section 179D of the IRC; and,

WHEREAS, ECG has presented the School District with the Government Building Primary Designer Acknowledgement ("Acknowledgement") in the form attached hereto and has informed the District that ECG is seeking the 179D deduction for the Energy Project; and,

WHEREAS, the Acknowledgement was reviewed by the Assistant Superintendent for Business and based upon said review, the District Administration recommends that the Board of Education authorize the execution of said Acknowledgment; and,

WHEREAS, said Acknowledgement requires the signature of an authorized representative of the Owner of the school buildings referenced therein;

NOW THEREFORE, BE IT RESOLVED THAT, based upon the review and recommendation as set forth hereinabove, the Board of Education hereby authorizes the Assistant Superintendent for Business to execute the Government Building Primary Designer Acknowledgement on behalf of the Board of Education

5. BE IT RESOLVED BY THE BOARD OF EDUCATION OF VALLEY STREAM UNION FREE SCHOOL DISTRICT TWENTY-FOUR, IN THE COUNTY OF NASSAU, NEW YORK, AS FOLLOWS:

Section 1. Tax Anticipation Notes (herein called "Notes") of Valley Stream Union Free School District Twenty-Four, in the County of Nassau, New York (herein called "District"), in the principal amount of not to exceed \$4,000,000, and any notes in renewal thereof, are hereby authorized to be issued pursuant to the provisions of Sections 24.00 and 39.00 of the Local Finance Law, constituting Chapter 33-a of the Consolidated Laws of the State of New York (herein called "Law").

Section 2. The following additional matters are hereby determined and declared:

- (a) The Notes shall be issued in anticipation of the collection of real estate taxes levied or to be levied for school purposes for the fiscal year commencing July 1, 2020 and ending June 30, 2021, and the proceeds of the Notes shall be used only for the purposes for which said taxes are levied.
- (b) The Notes shall mature within the period of one year from the date of their issuance.
 - (c) The Notes are not issued in renewal of other notes.
- (d) The total amount of any Notes so issued shall not be in excess of the total amount of such taxes remaining uncollected on the date of any such issuance.
- Section 3. The Notes hereby authorized shall contain the recital of validity prescribed by Section 52.00 of the Law and shall be general obligations of the District, and the faith and credit of the District are hereby pledged to the punctual payment of the principal of and interest on the Notes and unless the Notes are otherwise paid or payment provided for, an amount sufficient for such payment shall be inserted in the budget of the District and a tax sufficient to provide for the payment thereof shall be levied and collected.

Section 4. Subject to the provisions of this resolution and the Law, and pursuant to Sections 50.00, 56.00, 60.00 and 61.00 of the Law, the power to sell and issue the Notes authorized pursuant hereto, or any renewals thereof, and to determine the terms, form and contents, including the manner of execution, of such Notes, and to execute tax certifications relative thereto, is hereby delegated to the President of the Board of Education, the chief fiscal officer of the District.

Section 5. The Notes shall be executed in the name of the District by the manual signature of the President of the Board of Education, the Vice President of the Board of Education, the District Treasurer, the District Clerk, or such other officer of the District as shall be designated by the chief fiscal officer of the District, and shall have the corporate seal of the District impressed or imprinted thereon which corporate seal may be attested by the manual signature of the District Clerk.

Section 6. This resolution shall take effect immediately.

- **6.** Upon the recommendation of the Superintendent of Schools, the Board of Education hereby authorizes the District to enter into an agreement with The 13th Child Autism & Behavioral Coaching, Inc. for the 2020-2021 school year and further authorizes the President of the Board of Education to execute the necessary documents to effectuate said Agreement.
- 7. Upon the recommendation of the Superintendent of Schools, the Board of Education hereby authorizes the District to enter into an agreement with All About Kids SLP, OT, PT, LMSW, Psychology, PLLC (Academic Tutoring) for the 2020-2021 school year and further authorizes the President of the Board of Education to execute the necessary documents to effectuate said Agreement.
- **8.** Upon the recommendation of the Superintendent of Schools, the Board of Education hereby authorizes the District to enter into an agreement with All About Kids, SLP, OT, PT, LMSW, Psychology, PLLC (Related Services) for the 2020-2021 school year and further authorizes the President of the Board of Education to execute the necessary documents to effectuate said Agreements.
