I. CALL TO ORDER

The Business Meeting was called to order at 4:30 PM, at the William L. Buck School, by President Wheeler.

Motion to enter Executive Session at 4:30 PM was made by Maier seconded by Trustee Hernandez, to discuss Personnel and Contractual obligations. Motion unanimously carried.

Motion made to adjourn Executive Session at 5:59 PM was made by Trustee Wilson, seconded by Trustee Hernandez. Motion unanimously carried.

Superintendents Report: Welcomed all in attendance.

Dr. Sturz opened up the meeting by welcoming some of our staff in attendance to tonight's meeting. Dr. Sturz discussed the Nassau BOCES Summer Learning program at the William L. Buck School that is up and running and going very well. We approximately have 130 students in the program.

*To be eligible to receive tenure, the probationer must receive composite or overall APPR ratings of either effective or highly effective in at least three of the four preceding years, and if the probationer receives an ineffective composite or overall APPR rating in the final year of the probationary period she will not be eligible for tenure at that time.
