# VALLEY STREAM SCHOOL DISTRICT 24 MINUTES OF THE WORK SESSION / AUDIT COMMITTEE AND

# REGULAR MEETING OF THE BOARD OF EDUCATION

**September 21, 2016** 

The work session was called to order at the William L. Buck School by President Pellicane at 7:00 PM.

Members Present: President Pellicane, Vice President Maier, Trustees DePace, Hernandez, LaRocco and Wheeler.

Members Absent with Prior Notice: Trustee Iadevaio.

Others Present: Superintendent Fale, Attorney Zuckerman, and Director of Finance and Operations Mr. Jack Mitchell.

Meeting of the Audit Committee (the Board as a Whole) September 21, 2016

Mrs. Marianne Van Duyne from R.S. Abrams, our independent auditor, presented the final audit report of financial reports for the 2015-2016 school year at 7:00 PM. The District received an "Unmodified Opinion" which is the best opinion that a school district can receive.

The Board discussed the auditor's findings and asked questions of the auditor.

Motion: Vice President Maier, seconded by Trustee LaRocco that, upon the recommendation of the Superintendent of Schools and the Audit Committee (the Board as a Whole), the report from R.S. Abrams is hereby accepted by the Board for the year ending June, 2016. The Board authorizes a copy of this report to be sent to the State Education Department in accordance with Section 107.2(r) of the Commissioner's Regulations by the required filing date. Motion unanimously carried.

At 7:30 PM Senator Todd Kaminsky, Assemblyman Brian Curran and Assemblywoman Michaelle Solages discussed the Green Acres Mall/District 30 PILOT and committed to trying to find ways to minimize the impact on District 24 taxpayers and to provide notice about future PILOTS.

The Board then entered into Executive Session at 8:25 PM on motion by Trustee LaRocco, seconded by Vice President Maier, and unanimously carried, to seek advice from counsel about the PILOT and to discuss the Local 74 contract negotiations. The Board then exited from Executive Session to enter into the regular Board Meeting.

President Pellicane, called the Regular Meeting of the Board of Education to order at 8:40 PM.

Members Present: President Pellicane, Vice President Maier, Trustees DePace, Hernandez, LaRocco and Wheeler.

Members Absent with Prior Notice: Trustee Iadevaio.

Others Present: Superintendent Fale, Attorney Zuckerman, Director of Finance and Operations Mitchell, Director of Curriculum Dr. Conte, Director of Special Education Peterson.

President Pellicane welcomed questions or comments from visitors relative to the items on tonight's agenda.

Motion to approve the minutes of August 24, 2016 and September 7, 2016 by Trustee LaRocco seconded by Vice President Maier. Motion unanimously carried.

District Clerk Plinto reported that two letters of resignation were received.

Dr. Fale welcomed and introduced new staff to the District.

Dr. Fale introduced Mr. Vincent Milano Assistant Principal of the Summer School, who gave a presentation regarding the 2016 Summer School Program. There was a total of 222 students who attended, William L. Buck School 64 students, Robert W. Carbonaro School 88 students, Brooklyn Avenue School 68 students, Holy Name of Mary School 2 students.

Motion to move the entire agenda by consent by Vice President Maier seconded by Trustee DePace. Unanimously carried.

NOW, THEREFORE, THE BOARD OF EDUCATION OF THE DISTRICT HEREBY RESOLVES AS FOLLOWS:

That receipt of the Resolution of Valley Stream CHSD is hereby acknowledged, which identifies the District as an election district of Valley Stream CHSD with

voting to be held at the Brooklyn Avenue School located on Brooklyn Avenue, William L. Buck School located on Horton Avenue, Robert W. Carbonaro School located on Hungry Harbor Road and So. Corona Firehouse located on South Corona Avenue in Valley Stream, New York, on Tuesday, December 6, 2016, between the hours of 7:00 o'clock A.M. and 9:00 o'clock P.M. (Prevailing Time) for the purpose of voting on a Bond Proposition adopted by Valley Stream CHSD.

That the District Clerk shall be authorized to and shall implement the Resolution of Valley Stream CHSD in accordance with Education Law Section 1906 and the Legal Notice adopted by Valley Stream CHSD, and shall ensure the proceedings are the same as if the voting were held in one place, including, but not limited to, the registration of voters, preparation of registration books, rental and use of voting machines, appointment and payment of registration board members, election workers (including ballot clerks and poll watchers), and preparation, printing and distribution of absentee ballots.

All District costs relating to said Special District Meeting shall be borne by Valley Stream CHSD, and the District's business office is directed to maintain an account of such costs and to submit such costs to Valley Stream CHSD for payment and/or reimbursement. This resolution shall take effect immediately. Motion unanimously carried.

Upon the recommendation of the Superintendent of Schools, the Board shall approve the following Transportation Contract for 2016-2017. These prices are approximate awaiting bills and contracts will follow.
