February 22 – Mar 4 Voting

March 4 All ballots due by 9 am. to STA Office. Election Committee to count ballots.

March 5 Results mailed to sites and posted on STA website

**Challenges must be filed within ten (10) calendar days after announcement of results.**

**If run-off is necessary:**

March 8 Election Materials delivered to SUSD, posted on electronic voting site, and mailed to substitutes and members on leave

March 25 All ballots due by 9 am. to STA Office. Election Committee to count ballots.

March 26 Results mailed to sites and posted on STA website
