### NUTRITION\_PROGRAM

The Forest County Office on Aging Senior Nutrition Program provides hot meals with 1/3 of the daily nutritional requirements. It also offers socialization with volunteer opportunities along with connections to community supportive services.

The Office on Aging ensures that the Nutrition Program has qualified, properly trained staff. The site managers are required to have 6.5 hours of training each year per our contract with the state. A registered dietician reviews menus for Armstrong Creek, Crandon, Laona, and Wabeno. A Nutritionist reviews the menu for Alvin Meal Site.

Our volunteer home delivered meal drivers provide face-to-face personal contact with the home bound senior. Additionally, the drivers provide a safety check to those Seniors receiving a Home-Delivered Meal who may be frail or isolated. In some instances, this may be the only contact the Senior has that day.

#### FOREST\_COUNTY\_NUTRITION\_ADVISORY\_COUNCIL

The Nutrition Advisory Council shall advise the Nutrition Director on all matters relating to the delivery of the nutrition and nutrition-supportive services within the program area. All recommendations and suggestions of the Council shall be in accord with federal and state policies and shall take into consideration the nutrition budget. ### BUS\_ROUTES\_AND\_MEDICAL\_TRANSPORTATION

Forest County Commission on Aging provide transportation routes to seniors that are 55 years of age and older and/or disabled. The bus route offers several routes per month. We put Rhinelander, Antigo, and Iron Mountain on a rotation schedule with special events added monthly. The bus driver will pick riders up at their homes and assist with getting them on and off the bus as well as assist with delivering packages to their door. The cost to ride the bus is \$4.00 per day.

We also offer rides to and from medical appointments within a 125+ radius from Crandon. The rates for non-emergency medical transportation services are as follows:

- 1. \$10 for travel time of two(2) hours or less
- 2. \$20 for travel time of more than two (2) hours but less than four (4) hours
- 3. \$30 for travel time exceeding four (4) hours

Any long-term medical transportation services will immediately need to be reviewed with outside resources to determine qualification therein first.

### BEING A CAREGIVER

Nearly everyone will be a caregiver at some point in life, and nearly everyone will need a little help providing that care. Being responsible for someone else can feel overwhelming, especially if the role is unexpected. That is why Wisconsin offers family members and other informal caregivers' access to programming and education that can make being a caregiver more manageable. ### <u>FOREST\_COUNTY\_CAREGIVER\_COALITION</u>

The mission of the Family Caregivers Coalition in Forest County is to identify, recognize, support and enhance the role of those affected by caregiving through community outreach, education, peer support and shared resources in order to help family caregivers thrive. The Coalition meets at least quarterly to strengthen services and resources to caregivers in Forest County. ### <u>NATIONAL\_FAMILY\_CAREGIVER\_PROGRAM</u>

The National Family Caregiver Program provides services and supports that help family caregivers and informal caregivers, such as a neighbor or friend, care for elder adults at home. The NFCSP is available to any person providing care to an adult age 60 or over. There is no income limit, however, low-income individuals are prioritized. The program offers information about available services, assistance with gaining access to services, individual counseling to deal with depression or stress, caregiver support groups, training on providing safe and proper in-home care, and temporary respite services, such as help making minor home modifications or providing adaptive equipment that allows a person to remain living safely at home. ### <u> ALZHEIMER'S FAMILY CAREGIVER PROGRAM</u>

Created in response to the stress and needs of families caring for someone with Alzheimer's disease or another irreversible dementia. The purpose of the AFCSP is to make an array of community services available to families in hope of enhancing lives and keeping people in their homes as long as possible. Typical goods and services include respite care or home care services (personal care assistance, meal prep, homemaker services, yard work and snow removal, etc.), transportation expenses, home-delivered meals, home safety modifications, activity or hobby supplies, Lifeline, books and other resources to help the caregiver learn more about the disease and other services that are needed to help. The program requires a diagnosis from a physician and there is an income limit of \$48,000 per year; however, cost related to the individuals care can be deducted.

### STRONG\_BODIES\_EXERCISE\_PROGRAM

Healthy aging is all about quality of life. No matter how old you are, you do not have to get weaker with age. Strength training can help you stay vital, strong, and independent throughout your life. The Strong Bodies Program is a 12-week, evidence-based exercise program for all ages of men and women. Each class included progressive weight training, flexibility, and balance activities. Benefits from taking part in a program of strength training, which have been shown by research, include maintaining bone density, reducing falls, improving arthritis symptoms, increasing flexibility, and increasing strength. In addition, mental health benefits include improved mood and attitude, decreased depression, sleeping more soundly, increased energy levels and enjoyment of a new circle of friends.

Forest County Office on Aging has been partnering with the UW-Extension for the last seven years to offer the Strong Bodies Classes to the older adults in Forest County. We have trained leaders who volunteer their time and we collaborate with Karly Harrison, Healthy Communities Coordinator from UW Extension.

Strong Bodies classes are currently offered in Crandon and Armstrong Creek. There is no charge to participants that are 60+ years for any of these sessions. However, confidential donations are accepted. Weights will be provided. To begin the enrollment process, please pick up an enrollment form from the Crandon Public Library circulation desk or call Barb Tomaszewski at (906) 399-7506 to begin the enrollment process in Armstrong Creek.

### OTHER SERVICES

#### Stockbox

Stockbox is a program that provides healthy food every month to improve the diet and nutrition of low-income seniors, 60 and older. Stockbox provide a monthly supplemental food package for free, which includes; cheese, canned fruits, canned vegetables, juice, cereal, canned and dry milk, peanut butter, canned meat, canned soup, and rice, instant potatoes, or pasta.

You may qualify if: you are age 60 or older, you have a household income per month (before tax deductions) that is less or equal to Stockbox income guidelines:

Monthly income for one person in a household is \$1580, monthly income for two people in a household is \$2137, and for each additional person in the household, add \$557.

This program is sponsored by the Hunger Task Force.

#### **Veteran's Transportation Options**

Disabled American Veteran's (DAV) Route – DAV Van runs Wednesday and Thursday to Iron Mountain VA Medical Center. Reservations are made on a first come first serve basis and appointments must be made by 4:00 pm the Thursday prior to the week that a ride is needed. All riders must be ambulatory. The van cannot accommodate wheelchairs or oxygen containers. The driver cannot lift or attend medically to any passenger. Please refer to page 45 for contact information.

#### **ADRC**

#### Elder Abuse

Elder Abuse is a growing problem across the nation. There are many types of abuse. The most obvious is physical abuse. But there are other types of abuse that do not involve any physical violence that include verbal or emotional abuse, financial exploitation, sexual assault, and neglect or self-neglect. If you believe that someone you know is being or at risk of being abused, please call the Department of Social Services at 715-478-3351.

#### **Family Care**

Family Care is a Medicaid long-term care program for frail elders and adults with physical, developmental, or intellectual disabilities. People in this program receive long-term care services to help them live in their own home whenever possible. There are specific financial and guidelines to meet. Call the ADRC at 1-800-699-6704 for more information.

#### **Food Share**

A nutrition program is designed to ensure that all Wisconsin families have access to the food they need. Food Share Wisconsin is a new and improved version of the Food Stamp program. Although similar to the Food Stamp Program, Food Share Wisconsin offers more benefits including easier access and simplified eligibility rules. A person must live in Wisconsin, there are no work requirements for Food Share applicants and participants who are 60 years of age and older, and households with gross incomes at or below 200% of the Federal Poverty Limit are eligible for the Food Share Program. #### Kinship Care

This program provides financial assistance within program guidelines to blood relatives of children placed out of home and found to be in need of protection and services. Assistance is dependent upon availability of funding. Contact Forest County Department of Social Services at 715-478-3351 for more information.

#### **Medicaid**

Medicaid (not to be confused with Medicare) is a group of publicly funded programs to address health care costs for specific groups of individuals including the elderly (65+) and individuals determined disabled by Social Security. The programs have varying income and asset limits. #### <u>Medicare Advantage</u>

There are over 97 Medicare Advantage Plans available in Wisconsin and as you can imagine, sorting through all of them is confusing and time-consuming. We aim to be a trusted healthcare information source for aging adults and their loved ones because we believe everyone deserves high-quality, affordable healthcare coverage. Our newly updated resource on Medicare Advantage Plans in Wisconsin helps guide seniors through all of the available Medicare plans, eligibility requirements, enrollment guidelines, and their many benefits. #### **Medicare Part D**

Medicare prescription drug program for individuals eligible for Medicare. Medicare participants must have a Part D plan or approved creditable plans such as Senior Care. Contact Benefit Specialists in regard to Part D and creditable plans.

#### <u>Food Share Employment and Training (FSET)</u>

FSET is a free program that helps Food Share members build their job skills and find jobs. Through FSET, we offer job skills training, education activities, interview skills, and you can get work experience. FSET will help you get a job after we learn your strengths, needs, and type of work you prefer.

FSET provides support services to help you complete FSET activities including barriers to work. We'll help you pay for things you need for FSET activities, such as work clothes, tools, books, gas vouchers, and more. #### **DO YOU HAVE AN ADVANCE DIRECTIVE?**

You have the right to make decisions about your health care. This includes the right to accept or refuse medical or surgical treatment. You also have the right to plan and direct the types of health care you may receive in the event you become unable to express your wishes. You can do this by making an "advance directive."

#### WHAT IS AN ADVANCE DIRECTIVE?

An advance directive describes, in writing, your choices about the treatments you want or do not want or about how health care decisions should be made for you if you become incapacitated and cannot express your wishes.

An advance directive expresses your personal wishes, beliefs and values. When you make an advance directive, you should consider issues like dying, living as long as possible, being kept alive on machines, being independent, and quality of life.

Addressing these issues may be difficult but it is necessary if you want others to follow your wishes. In Wisconsin, if you are 18 years of age or older and of "sound mind," you can make an advance directive. An advance directive speaks for you when you are unable to speak for yourself.

#### **HOW DO I MAKE AN ADVANCE DIRECTIVE?**

There are three ways to make a formal advance directive in Wisconsin. You can complete either a living will or a power of attorney for health care document. You do not need an attorney to complete these forms. However, two persons must witness your signature. The forms describe who may or may not be a witness. A third way to express your wishes is to have a legal document drafted by your attorney and appropriately witnessed.

#### WHAT IS A POWER OF ATTORNEY FOR HEALTH CARE?

The power of attorney for health care is a document in which you appoint another person (a "health care agent") to make health care decisions for you in the event that you are not capable of making them yourself. A health care agent can make a wide range of health care decisions for you, such as whether or not you should have an operation, receive certain medications, or be placed on a life support system.

In some areas of health care your health care agent is not allowed to make decisions for you unless you give him or her specific authority in those areas when you complete the form. These areas are admission to long term care facilities, limitations on mental health treatment, health care decisions for pregnant women, pregnancy care and provision of a feeding tube.

Your health care agent will make decisions for you based upon your directives, his or her knowledge about you and your wishes, and his or her opinion about what is best for you. It is important to choose someone who knows you well and to discuss your treatment preferences with him or her in advance. You can also include specific instructions about the type of treatments you want or do not want, e.g., surgery, when you complete the form.

A power of attorney for health care goes into effect only when two physicians, or a physician and a psychologist, agree in writing that you can no longer understand your treatment options or express your health care choices to others. 



# Important Information about turning 65

There was a time, not too long ago, when 65 was "the" age.

It was at age 65, after a lifetime of labor, that most people could look forward to receiving full Social Security retirement benefits and becoming eligible for Medicare.

- 65 remains the age for Medicare eligibility.
- Full retirement age has been on the rise for all workers born after 1937.
- Social Security does not send out reminders about Medicare eligibility unless you are already collecting Social Security benefits.



- There are several parts to Medicare:
  - ◆ Part A—Hospital
  - ◆ Part B—Medical
  - ◆ Part C—Hospital & Medical coverage through a private insurance company
  - ◆ Part D—Drug Coverage
- Participation in Medicare is voluntary, but if you fail to enroll during the initial enrollment period for Parts B and D, you can be subject to a late enrollment penalty for the rest of your life.


