# Watertown Township Monthly Board Meeting Minutes April 1, 2024 7:00pm

The Watertown Township Board met on the above date for a regular board meeting to audit and allow orders, and to transact any business to come before it.

The meeting was called to order by Chair Scott Hoese at 7:00 PM.

#### **Treasurers Report**

Receipts for the month as of 3/31/2024 equaled \$9007.96 and total disbursements of \$30,933.36, giving an ending balance of \$204,736.42, and an investment balance of \$488,934.20, therefore giving a grand total balance of \$693,670.62

A motion to approve the Treasurer report was made by Jerry Brunner and seconded by Kathy McCann.

#### **New Business**

Residents of Hainlin Drive issued a complaint regarding unauthorized parking on the roadway near Mud Creek as well as trespassing and littering in this area.

Following discussion, a motion of resolution was made by Kathy McCann and seconded by Jerry Bruner to erect official "No Parking" signs along the length of Hainlin Drive in accordance with the township's no parking ordinance.

Motion carried.

The township clerk will inform the residents accordingly.

Hainlin Drive Bridge. This wooden bridge is currently in good condition though in time will need replacement, thus discussion was had regarding the steps necessary with various agencies to initiate the replacement process. The clerk will bring more detail in this regard to upcoming meetings.

### **Old Business**

New Western Star truck warranty. The dealer is offering a variety of warranty options (3, 5 and 7 year) including separate extended warranties for the engine and the truck.

Costs range from \$4,000 to \$11,600, depending on length in years.

Following discussion, the BD asked the Clerk to seek out more detail and options regarding truck warranty.

Sale of 2007 Mack dump truck. The board discussed various selling options including advertising in the MAT magazine, obtaining a firm trade in price from the dealer, placing the truck up for bids, and possibly working with a heavy equipment auction house. It was suggested we start with a \$95K asking price when listing.
