Treasurers Report

Receipts for the month as of 731/2023 equaled \$97,445.10, and total disbursements of \$152,864.25, giving an ending balance of \$359,912.94. Investment balance equaled \$338,008.91, therefore giving a grand total balance of \$697,821.85.

A motion to approve the Treasurer report was made by Kathy McCann and seconded by Jerry Bruner, Motion carried.

New Business

A liquor license renewal request was submitted by B's on the River along with a check for the annual renewal fee. A motion was made by Jerry Bruner and seconded by Kathy McCann to approve this renewal request. Motion carried.

Nesvold solar field vegetation control has not kept up with the growth this summer and is therefore not meeting requirements. Contact was made with owner Engie, and as a result Cannon Valley Grazers has brought out a herd of sheep for 4 weeks of vegetation control. Water is needed and the township was approached to provide that supply. Following discussion, a motion was made by Jerry Bruner and seconded by Kathy McCann to approve this request for a fee of \$150. Motion carried.

Old Business

Road tour resulting action items were reviewed, and following a motion was made by Kathy McCann and seconded by Jerry Bruner to proceed with the items noted (see attached list). Motion carried.

The solar ordinance litigation hearing date has been moved from July 31, 2023, to January 2024.
