# **Treasurers Report**

# **New Business**

Gravel mining recommendation requests for IUP's and set back variances were made by Joe White of BH Aggregates, Kimball, MN., to mine gravel (approx. 667,000 yds) from parcels 100301100 and 100311420, owned by Tom and Jody Lubke, residing at 5475 County Rd 23, Mayer, MN.

Mining to take place commencing late 2024 and ending by year end 2026, upon which all mining would cease and the sites would be reconstructed to near original per a comprehensive mining plan agreement. Following discussion regarding mining elevations, site dust control, setbacks, safety practices, signage, truck routing, back fill materials, etc, a motion was made by Jerry Bruner and seconded by Kathy McCann to provide positive recommendations for an IUP and the setback variance requested for both sites.

Motion carried.

A CUP and a variance request was made by Bill and Teena Dietz, representing Serenity Acres Holding LLC, located at 11185 County Rd 24, Watertown, MN., providing horse related therapy for individuals in need. This site had an operating CUP under the name of Red Door Ranch but was sold in 2023 to the above party. The Dietz family is requesting a CUP to operate Serenity Acres as a horse therapy business, and a variance to allow this property to have a homestead credit even though the owners would not be living on the property. The owner's daughter however would become a resident on this site during 2024. Following discussion, a motion was made by Jerry Bruner and seconded by Kathy McCann to provide a positive recommendation for the CUP as well as the variance request.

Carver County requested an immediate estimate of flood damage and a figure of \$5000 was given as a place holder at this time, as water levels have not yet receded.
