

## Recycling at ATHC Douglas Kugler Eco-Site

The Eco-Site accepts a variety of items for recycling as well as provides a free re-use room stocked with household products in good condition.

Items collected free of charge: batteries, cartridges, clothing, shoes, household items, cooking oil, holiday lights, plastic bags, paper, bottles, cans, residential fluorescent bulbs, scrap metal, used motor oil/filters/antifreeze.

Items collected for a fee: appliances, bicycles, business electronics, car seats, commercial appliances, lawnmowers, small engine devices, residential electronics, tires, business fluorescent bulbs.

Remember it is illegal to dump in ditches per MN Statute 169.42 Sub 1. Illegal dumping cost the Township \$800 in 2015.

#### **Burn Permits**



Burn permits are available by calling Si Tesch at 952.955.1120 or online at http://www.dnr.state.mn.us/burningpermits. An **annual burn permit is \$5**. Residents must call the number on the form prior to burning on that particular day.

## **Snow Plowing Ordinance**

It is unlawful to deposit snow on or next to a public highway or street. MN Statute 160.2715 and Watertown Township Ordinance prohibits the plowing, blowing, shoveling, or otherwise placing of snow onto public roadways. This includes the ditch and right of way along the roadside.



Violations are considered misdemeanors and civil penalties apply if the placement of snow creates a hazard, which extends to the property owner and the person who placed the snow.

## Mowing of Road Right-of-Way

It is advised to not blow grass clippings or other debris into roads or road right of ways per MN Statute 160.2715. When debris is blown into Township roads, it creates traveling motorist safety and road maintenance concerns.

## Farming of Road Right-of-Way

Tilling and planting a crop within the road right-of-way can cause erosion, roadbed damage, and interfere with drainage. It is **unlawful to perform unauthorized work within a road right-of-way** per MN Statute 160.2715. A typical right-of-way is 66 ft, extending 33 ft from the center of the road.

#### Proposed 2017 Levy

The 2016 annual levy consists of a General Levy of \$97K and Road & Bridge of \$276K, totaling \$373K. Road & Bridge funds are allocated as base road maintenance of \$121K, dust coating/road stabilization of \$55K, and road projects of \$100K.

#### Solar Farms/Gardens

This past year, there has been discussion regarding solar farms/gardens in the Township. These solar farms/gardens are being privately developed for the purpose of generating electricity.

A proposed solar farm/garden bordering the Township Hall to the south is progressing through the permitting process.

#### **Police Contract**

After discussion at the 2015 annual meeting, a motion was made and accepted to not sign a 2015 Police Contract unless we were eligible to receive Police Aid Reimbursement. The eligibility may have been possible if the MN State Legislature had overturned the ruling to not receive the portion of motor vehicle ticket proceeds. This was not on the 2015 Legislative agenda.

# Resident Dust Coating and Class-5 Gravel Purchases

Dust coating and class-5 gravel are available for purchase by any resident for use within the township on an one-time purchase basis.

Quantity (10 load limit) and payment must be received by May 1. Cost will be the same as the Township and known by the annual meeting.

Delivery is determined by the road conditions but is generally late May and supplied by the Township contractor.

## **Mailbox Supports and Purchase**

The mailbox support is the personal property of the homeowner and is the only property that can be in the road right of way.

To help reduce your liability (damages caused by a third party), install a swing-away mailbox support that meets crash test approval.

Watertown Township will help with the costs by purchasing and installing the mailbox support for you for a **fee of \$75** (half of the Township cost).
