7. <u>Any other matters in connection with the District's May 4, 2024, Election.</u> Chuck Carpenter wanted everyone in attendance to understand the sales tax election will not increase your taxes. The majority of the sales tax is already being collected through internet sales, streaming services, and utility usage. This election allows the funds to be sent to the District instead of the state keeping them. David explained the board set aside \$30,000 for election expenses. If the election passes, the District will not know the amount of funds it expects to collect for 12-18 months. The desire is to lower the tax rate for property taxes in the future but that cannot be promised at this point since the amount is unknown.

A question was asked about the timing if the election succeeds. No one knows at this time when it would go into effect. The state is paid sales tax quarterly, but distributes it a quarter behind.
