Pursuant to Section 551.023(b) of the Texas Government Code, the Board has adopted reasonable rules to maintain order during open meetings, including the location of any recording equipment and the manner in which the recording of a meeting is conducted. Members of the public intending to record a District meeting shall sign in on the provided sign in sheet prior to the start of the meeting and any recording equipment larger than a handheld size shall be located only where designated by the Board in advance.

The Board may retire to Executive Session any time between the meeting's opening and adjournment for any purpose authorized by the Texas Open Meetings Act, including, but not limited to: consultation with legal counsel (Section 551.071 of the Texas Government Code); personnel matters (Section 551.074) and/or discussion of real estate acquisition (Section 551.072). Action, if any, will be taken in open session.
