## **BACKGROUND:**

The City of El Mirage is a participating entity in the Arizona Metropolitan Trust, which the Council approved membership in by Resolution R21-03-04 effective July 01, 2021. The City's current term of membership ends on June 30, 2024. The Trust's Board of Trustees has offered a renewal of membership to El Mirage commencing July 01, 2024. The City of El Mirage wishes to renew its participation in the Trust for a three (3) year membership period commencing July 01, 2024, and terminating June 30, 2027. The AzMT will experience a 4% increase in medical premiums, a 0% increase in dental premiums, and a 0.5% increase in vision premiums for the 2024-2025 fiscal year. Renewal of the City's membership in the Trust will serve the interest of the City and its employees. Authorizing the renewal of membership in the Trust has no fiscal impact as benefit costs are addressed separately through the annual budgetary process.

Three quotes were received, and DCS Contracting, Inc. submitted the lowest responsible quote for the project. This action item seeks approval to perform this work in accordance with the pricing and terms of the City of El Mirage JOC contract PW23-RFQ-JOC01 for an amount not to exceed \$105,032 and authorize the finance department to make any necessary transfers.

## **BACKGROUND:**

The Police Department uses Leads Online in our Investigations Department for quick and comprehensive ways to run case information to identify people, property, and patterns to advance cases faster. The amendment to our current contract changes Leads Online billing to match our fiscal year. Currently, Leads Online invoices in March, but the billing is for the next fiscal year starting July 1st. Updating the billing to match our fiscal year would help alleviate past-due payments. Another benefit is this update does not change the pricing that we currently have. The attached contract shows a prorated amount of \$555 for May and June 2024 and \$4,442 for the FY24/25 contract year, totaling \$4,997.00.
