In our most recent event held at the flavorful Gourmage Winery in New Braunfels, TX, esteemed Professors from Texas State University, Dr. Ashleen Menchaca - Bagnulo (Political Science) and Dr. Bryan Glass (British History) led patrons through a lively discussion on one of the most pressing political questions of today's age. In the wake of mass shootings, is the 2nd amendment still functional to ensure domestic tranquility?

Dr. Glass recalled us back to the original intent of the 2nd Amendment as well as the history and relationship between the colonies and King George III. Coming in to lead the crowd in a Socratic dialogue, Dr. Menchaca-Bagnulo elaborated on the U.S. Supreme Court decision, *District of Columbia vs. Heller* (which discussed the individuals right to carry a handgun in the D.C. Area). She would then go on to make a social comment on a possible moral degradation of humanity that may be perpetuated by the digital media age. The patrons engaged back with a barrage of insightful questions from both young and older generations!

As the dialogue came to its end, our lectures and patrons participated with passion in one our most ancient of traditions, political discussion. *The Constitutionalist Foundation* takes these moments as sacred, for they further educate the next wise and prudent patriots to formulate, with confidence, through careful cogitation their, sound political positions on the constitutional issues of today.




Board Member Spotlight:
