Cochise retail, restaurant and bar sales up, lodging down in August

BENSON— In August 2025, Cochise County's estimated retail and restaurant and bar sales were up, while hotel/motel receipts were down, compared to August 2024 (after adjusting for inflation).

August retail sales in Cochise County were up 1.4 percent from August last year, compared to a 1.0 percent increase for all Arizona. From January through August, Cochise County's retail sales were down 0.2 percent while statewide sales were up 1.0 percent (compared to the first eight months of 2024).

The inflation adjustment subtracted 2.9 percentage points from August year-over-year growth rates and 2.6 percentage points for the first eight months. As a result, Cochise County's nominal retail sales growth of 4.3 percent in August was adjusted downward to 1.4 percent. For the first eight months of 2025, nominal growth of 2.4 percent was adjusted to -0.2 percent. Inflation adjustments are made using CPI-U measuring the general rate of inflation.

Sales by remote sellers (those without a physical presence in Arizona and with annual gross sales instate of \$100,000 or more, including online sales from sellers in other states) were up 23.6 percent in Cochise County in August, after inflation, compared to a 26.8 percent increase statewide. For the first eight months of 2025, remote sales were up 13.0 percent in Cochise County and 13.3 percent statewide.

Cochise County's restaurant and bar sales were up 11.4 percent in August, after inflation, and 5.3 percent for January through August. Statewide, Arizona's restaurant and bar sales were up 4.0 percent in August and 0.7 percent for the first eight months.

Hotel/motel receipts in Cochise County were down 1.3 percent in the August comparisons but were up 0.7 percent for January through August. Statewide, lodging receipts were down 8.9 percent in August and 4.5 percent for the first eight months of the year.

At the city level, estimated retail sales in Benson were up 0.4 percent in August but were down 1.7 percent for the first eight months of 2025, after inflation. Restaurant and bar sales were up 9.7 percent in August and 10.3 percent for the first eight months. Hotel/motel receipts in Benson were down 54.1 percent in August and 35.8 percent for January through August.

In Bisbee, retail sales were up 22.8 percent in the August comparisons but were down 3.5 percent for the first eight months of the year. Restaurant and bar sales were up 13.9 percent in August but were

down 8.2 percent for January through August. Bisbee's hotel/motel receipts were down 31.5 percent in August and 13.6 percent for the first eight months, compared to the same period a year ago.

In Douglas, retail sales were down 1.5 percent in August and 2.8 percent for the first eight months, after inflation. Restaurant and bar sales were up 16.4 percent in August and 1.6 percent for January through August. (Hotel/motel estimates are unavailable for Douglas due to the small number of establishments and state department of revenue confidentiality rules.)

Huachuca City's retail sales were up 0.6 percent in the August comparisons and 8.8 percent for the first eight months of the year. (Restaurant and bar and hotel/motel estimates are not available for Huachuca City due to the small number of businesses and tax confidentiality rules.)

Retail sales in Sierra Vista were up 0.2 percent in August but were down 1.0 percent for the first eight months, after the inflation adjustment. Restaurant and bar sales were up 11.7 percent in August and 5.8 percent for January through August. Sierra Vista's hotel/motel receipts were up 8.7 percent in August and 0.5 percent for the first eight months.

Tombstone's retail sales were down 9.1 percent in August and 5.2 percent for the first eight months of 2025. Restaurant and bar sales were up 9.4 percent in August and 4.6 percent for January through August. Hotel/motel receipts in Tombstone were up 19.7 percent in August and 16.1 percent for the first eight months of 2025.

In Willcox, estimated retail sales were down 13.2 percent in the August comparisons and 5.4 percent for the first eight months of the year. Restaurant and bar sales were up 15.4 percent in August and 17.5 percent for January through August. Willcox hotel/motel receipts were up 11.7 percent in August and were down less than 0.1 percent for the first eight months of 2025, after inflation.
