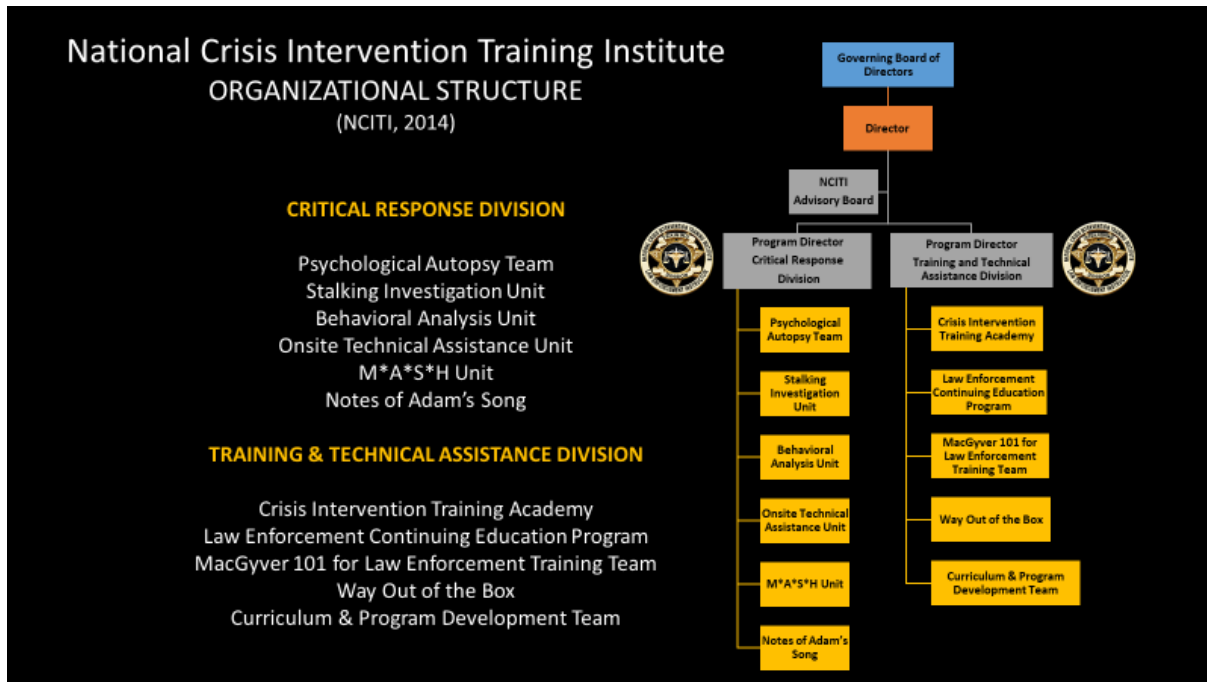

### TRAINING ENVIRONMENT FORMATS

**Live Webinar:** Consists of concurrent attendance of a live webinar, while the on-site class is in attendance. Random pop quizzes and/or attendance check-ins are conducted throughout the day to ensure the persons attending remotely are actually participating and attending the class.

**On-Site Course:** Attendees are in actual attendance at a local training site. Attendance is taken at the beginning and end of each day.

**Hybrid Format:** Attendees may opt to attend certain initial days of the training course via the above-described "Live Webinar" format, but then are required to attend final day(s) of training in a Practicum setting, where live interactive exercises, role-playing, group discussions and scenario-based exercises are conducted. The Hybrid format is designed to aid Participants who, for financial or other personal reasons, may not be able to travel to and from the training site each day of the multiple-day training course.

### NCITI CERTIFICATION

**Certification Courses:** Consist of certain courses within the NCITI Curricula, in which Participants who are Certification Candidates are required to demonstrate knowledge and skill proficiencies via written post-tests, as well as group and/or individual practical testing, which qualitatively assesses the Participants' skill proficiency. Certification is usually for a prescribed period of time (typically two years); re-certification is required to ensure that the certified Participant receives updated information, and maintains skill proficiency.

Certification may also be granted to individuals who complete a certain number of related courses offered by NCITI, or by submitting proof of prior completion of comparable training courses, alongside NCITI training.

**Train-the-Trainer Courses:** Veteran Practitioners who have worked in the field for a minimum of one year as a Certified Practitioner may be selected to receive NCITI Certification to teach one or more of the NCITI courses.

**Mentor Certification:** Consists of one-on-one evaluation of a Practitioner's skill and knowledge levels, based upon examination of education, training, and professional experience. **Course Title:** *A Solution that Kills: A Closer Look at Addiction and Drugs of Choice*

**Course Description:** This 8-hour course provides an overall orientation to substance misuse, abuse, dependence, and addiction. Various behavioral and mood-mind-altering substance-based “drugs of choice,” such as sexual addiction, will be compared and contrasted to substance-related addictions. The student will receive a comprehensive understanding of the relationship the suffering addict forms with his/her drug(s) of choice, and co-morbidity factors which enhance the probability of relapse. Also, the collateral damage inflicted upon family, friends, employers, significant others are covered.

**Course Description:**                      The Basic 16-hour course covers the nature and scope of the problem of child abuse and neglect, covering various forms of physical, emotional, and sexual abuse and exploitation, as well as varying levels of child neglect. Behavioral, interpersonal, and physical danger signs are graphically demonstrated and displayed. The student will also be oriented to specialized techniques recommended for communicating with child abuse and neglect victims, their family members, and possible perpetrators. Rules of evidence, and procedural techniques are discussed and demonstrated, relevant to the criminal investigation of child abuse and neglect. The Basic course is intended as a pre-requisite for the 16-hour Advanced Child Abuse Investigation course, which includes advanced training in victim/witness interview, case management, family reunification, and monitoring techniques.

**Course Description:** In death investigations, the finding of mode and manner of death is sometimes more complicated than it appears on the surface. Such is the case of “coerced suicide” in which private parties create a psychological environment which pushes the victim toward an act of suicide. The material in this course also covers tactics of so-called “suicide-rights advocates,” who facilitate the deaths of depressed and distraught people, as well as recommendations for pro-active identification and apprehension of people who literally “help someone to death.” The presentation of this material culminates in a case study, in which course participants identify indicators in suicide notes and case facts which support the theory that the apparent act of suicide was directly caused by coercive acts and/or threats made by third parties. Prosecutorial options will also be discussed.

**Pre-requisites:** No mandatory pre-requisites; prior training and/or experience in interviewing techniques highly recommended. **Special Equipment:** None.

**Course Description:** This 16-hour advanced investigation course focuses on the utilization of cognitive interviewing as a memory retrieval tool in aiding victims, witnesses, and suspects in recalling factual details which are sometimes suppressed due to traumatic co-morbidity factors, and/or are not contemporaneously noted in detail. Evidence-based methodology and specialized techniques for law enforcement and clinical interviewers are explained and demonstrated, as well as careful guidelines which must be followed to help ensure that false-memories will not be created. Limitations, advantages, and cautionary considerations are covered, as well as methods of protecting Legal admissibility of cognitive and emotional recall will be covered, as well possible complications that may arise as a result of either appropriate or inappropriate application of this interviewing method. Alternative, potentially dangerous, and/or faulty methods of so-called “memory retrieval” which should be avoided for legal, ethical, and other reasons will be covered. The students will be given opportunity to practice and demonstrate the actual techniques taught in this course.

**Course Description:** This 8-hour in-service training course is an expansion of the “Cold Case” segment of the NCITI “Missing Persons” and “Psychological Autopsies” courses. The course focuses on the definitions of “cold cases,” the procedural and definitive methodologies attached to sustained case investigation, as well as the unique challenges faced by the Investigator in solving cases where an appreciable amount of time has elapsed between the incident and the initiation of the cold case investigation. Specialized techniques designed and utilized by NCITI personnel, as well as recognized investigative authorities in the area of cold case investigation will be outlined and described.

**Course Description:** This 4-hour in-service training course describes the various forms of psychological and physical assaults often committed by person who are detained, arrested, or imprisoned. The training also discusses recommended preventative and cautionary measures. This course is also combined with

Staff Seduction (CLEET COURSE # 19-2280) to form a combined 8-hour course entitled “Guerilla Warfare: Psy-Ops by Human Predators Against Corrections/Law Enforcement Personnel (CLEET COURSE # 19-2281).

**Cost:** Attendance is **FREE** for Oklahoma peace officers Only at CLEET-Sponsored Training Events. **Course Title:** *Empathetic Interrogation of Sexual Offenders and Predators* (Parts One and Two) Part One also known as *Sexual Offender and Predator Psychology*

**Course Description:** This 40-hour training program consists of a 16-hour orientation to various general psychological, emotional, cognitive, behavioral disorders which are common co-morbidity contributors to sexual offenses, as well as multi-faceted descriptive models to aid in identification, classification, and field assessment of various types of sexual offenders, sexual predators, and serial killers. 24 hours of this training course cover issues related to the Empathetic Interrogation methodology, with emphasis given to interview and interrogation of sexual offenders and predators.

The Empathetic Interrogation utilizes innovative techniques to conduct pre-interrogation profiling assessments of sexual offenders, to aid in selecting interrogatory themes which are most likely to be efficacious with a suspect’s particular psychological framework. Various techniques, not commonly used in other interrogation methods, are used in all phases of this 16-step process. The model covers pre-interrogation, peri-interrogation, and post-interrogation techniques and processes. This training is not designed as a replacement for the “Reid Technique.” In fact, the Trainer/Author of the Empathetic Interrogation Method is “Reid-trained.” ***The Empathetic Interrogation Method, however, provides many additional tools which are not provided in Basic or Advanced Reid Technique.***

**Class Schedule:** Flexible: May done in daytime format or two 4-hour sessions.

**Pre-requisites:** N/A      **Special Equipment:** N/A

**Course Description:** This 25-hour training course is designed to equip law enforcement investigators and other select professionals with state-of-the-art information and technical training, pertaining to a myriad of categories of missing persons. This includes, but is not limited to, voluntary and involuntarily-missing children, youth, and adults. Also covered are a variety of different risk co-factors and co-morbidity risk factors, and the problematic environments which are created due to human trafficking, prostitution and addiction lifestyles, and underground environments connected to custodial interference and parental kidnapping cases. On the third day of training, a “working lunch” is scheduled, during which a table-top group exercise is conducted. This allows for 25 hours of completed training, rather than 24. Since this course also qualifies for Mental Health hours, a Participant will complete the minimum state requirement for annual Continuing Education course completion (with the exception of Firearms Requalification).

This course focuses on methodology for establishing and utilizing a multi-disciplinary approach to psychological autopsies as an investigative tool, in both confirmed and undetermined-causation sudden death cases. Course content addresses victimology, suicidology, deductive criminal profiling, and also applicable aspects of grief and bereavement therapy. Its content is also helpful in establishing multi-disciplinary psychological autopsy teams, as well as expansion of already-existing multi-disciplinary treatment and child abuse investigation teams which may be looking to extend their scope of practice and focus in to the realm of death investigation. While not mandatory, it is highly recommended that attendees of this course also attend 14-0940 (Sexual Offender and Predator Psychology). On the third day of training, a "working lunch" is scheduled, during which a table-top group exercise is conducted. This allows for 25 hours of completed training, rather than 24. Since this course also qualifies for Mental Health hours, a Participant will complete the minimum state requirement for annual Continuing Education course completion (with the exception of Firearms Requalification).

The subsequent 40-hour Certification Course is available to those who have completed 19-0673. The course consists of 1:1 mentorship and instruction, as the Practitioner completes all phases of a hypothetical Psychological Autopsy case, based upon a case scenario provided by the Instructor. Completion of this course designates the Practitioner as a Certified Practitioner, with possible invitation to become an active member of one of NCITI's Psychological Autopsy Teams.

This technique is not intended as a therapeutic diagnostic tool, but, rather to hone in on various themes which are likely to be adopted by the suspect, in order to mitigate or explain his/her aberrant behavior...thus facilitating statements of emotional admission and, ultimately, confession. While its primary focus is on identifying and addressing various sexual pathologies, it is highly applicable to other criminal behaviors stemming from pervasive personality disorders, addictions, and socio- and/or psychopathology.

Attendees will participate in actual electronic role-play exercises, in which they will develop techniques for impersonating children and youth targets, as well as adult co-offenders, and will be familiarized with vocabulary and coded messages often used during “sexting,” and other related internet communications.

They also often enjoy exemplary public persona and pristine criminal, traffic, credit, and social records, while living secretive, double lives as sexual offenders and predators. For these reasons, standard “background investigation” queries often render negative results, resulting in a sexual predator being placed in a position of trust with a vulnerable child. This course provides identification and detection information and techniques, covers the gambit of standard background investigation techniques commonly used, and also trains the participant to administer and interpret an innovative tool, called the Volunteer Applicant Screening Interview. In addition, the legal aspects of what organizations should and should not do and ask during application processes for employees and certain protected populations of volunteers is covered in this training course.

**Course Description:** This training course, part of which is a segment of 14-0939 and 14-0940, focuses on Sexual Stockholm Syndrome – Type III, a phenomenon common in sexual human trafficking situations, forced prostitution, et cetera. This course material also covers first-response intervention strategies for law enforcement, as well as more sustained therapeutic strategies to be utilized and recommended by clinical and non-clinical helping professionals, and the courts.

**Course Title: *Victimology as an Investigative Tool: A Guide for Investigators and Clinicians***

**Course Description:** This eight-hour course focuses on “victimology,” specifically focusing on the study of victims of exploitative and/or violent crimes. Participants in this course will be familiarized with various ways to incorporate general victimology procedures to enhance investigative techniques in various types of criminal investigation. Covered topics include, but are not limited to, an overview of the



nature and scope of the problem, behavioral, physical, and environmental danger signs, risk factors, common traits per category of victim typology, et cetera. The course provides clear, concise guidelines for evaluating the victim's lifestyle, state of mind, patterns of behavior and behavioral chronology, location, vulnerabilities, and co-morbidity factors which may have contributed to the likelihood of them being targeted as a victim by a predator. Victimology is helpful in identifying previously-unidentified "unsubs" (unknown subjects) still at large, as well as in formulating intervention and treatment strategies to aid in the recovery and healing of victims of various forms of trauma. This course is appropriate both for law enforcement, clinical professionals and para-professionals, prosecutors and judges, and other interested helping professionals engaged in assisting victims and their families.

Covered topics include, but are not limited to, an overview of the nature and scope of the problem, behavioral, physical, and environmental danger signs, typical and atypical behavioral responses in abused and exploited children, and recommended first-response strategies to complaints and first outcries. This course is also highly recommended for any persons involved in the juvenile and family court systems, or helping professionals who deal with victimized and endangered children and their families.
