

The Witches Markets

Application & Vendor Rules

All applicants must be a small business owner who offers unique items. **We are juried show.** You must include pictures and descriptions of your products with your application otherwise it will not be reviewed.



All products must fall into one of the following categories:

Metaphysical, Oddities & Curiosities, spiritual, magical practice related, plants, occult related, Renaissance fair related items.

Some clothing items could be considered

All baked goods must follow the market themes and requirements.

Application Expectations

Completing an application does not guarantee acceptance into the market. Only one (1) application is required for the season.

Incomplete applications are automatically rejected from consideration.

Market's Expectation of Vendor

Vendors may only apply for no more than 2 categories to keep the market unique.

Vendors may not share booth space with other shops. Only 1 shop per booth. If caught both vendors will be banned from all Witches Markets.

ALL vendor products are subject to the Witches Markets approval. You can be asked not to have a product in your booth for any reason. This is considered a first warning violation. A second warning violation could result in your immediate removal and being banned from all markets for the remainder of the season and/or future market seasons.

All vendors are responsible for adhering to and/or obtaining correct licensing for local county, state, and federal regulations & requirements.

Vendors selling produce by weight must provide "legal for trade" scales and are subject to inspection by the Department of Agriculture's "Weights and Measures" program. The scale's display readers must be visible to the customers.

Prepared foods & bake goods vendors must meet the State's regulatory requirements.

The Witches Markets are an outdoor, rain or shine event.

Taxes, Insurance, Licenses, Permits and Special Requirements:

Any applicable retail sales taxes are the responsibility of the individual vendor.

The Witches Markets does not cover individual vendors. It is necessary that all vendors carry their own liability insurance.

Set Up Policy and Needs:

Be ready by the appropriate setup times and break down at the appropriate times (no earlier). If you sold out, you are asked to stay set up until the end of the market to prevent any empty spaces.

Do not park in the market locations any sooner than 20 minutes prior to setup, without expressed permission from Isaac. If you are parked at the location sooner, you will be removed from the markets.

You must provide your own tables, chairs, display equipment, tent and solar or battery-operated lights. Remember it will be night and dark outside.

A tent is optional. If using a tent, it must be in good condition and properly weighed down due to wind conditions.

Signage that represents your business and goods.

Pricing labels for all products must be clear and visible to all customers.

The look and feel of The Witches Market is important to the vendors, customers, and community. All vendor's products and equipment must be in good working order and neatly displayed.

At the end of the market make sure you leave your assigned area clean and litter free. Do not leave or dump your own waste in the receptacles around the facilities/parks.

If you set up before the appropriate time given, or without express written permission, you will be asked to pack up and leave, upon a first-time violation. You will also be banned from all markets for the next 40 days. A second violation will result in you being banned for 365 days from all markets.

Market Etiquette:

Price undercutting is strictly prohibited.

Vendors are expected to present and sell high quality products and handle any return issues if needed respectfully.

Children must be always supervised. The Witches Markets is not responsible for their safety.

The Witches Markets 2026 Vendor Application

Vendors & their representatives should conduct themselves in a respectful manner, be safe and courteous with customers, market staff and each other.

Smoking is only permitted in designated areas approved upon by each location. Consumption of alcohol and controlled or illegal substances while working at the market is strictly prohibited.

Do not touch other vendor's table, chairs, totes, boxes or anything without their express permission.

Payment and Cancellation Policy

All payments are to be made no less than 2 weeks prior to the Market you are participating in. Payment is made through the website portal.

www.thewitchesmarkets.com click on the Vendor link from the menu or on the main page. This will take you to the vendor payment portal.

If you have not made your payment 2 weeks prior to the market, you will not be placed on the vendor list. After 2 times of this, you will be removed from the season's markets as a vendor and will need to re-apply.

Regarding cancellations there is a 2-strike policy. If you are canceling as a vendor, you must do so before the 72-hour mark, barring actual emergencies. If you cancel under the 72-hour mark 2 times you will forfeit any future market dates. A few exceptions will be made.

Complaint Policy

Vendor complaints should be expressed in a written form and given to the market manager.

Customer complaints will be first handled by the vendor.

If a customer complains to The Witches Markets Coordinators/Director/Board Member(s) or appointed staff regarding a vendor, an appropriate person from The Witches Markets will discuss the complaint with the vendor and find a solution to the disagreement together.
