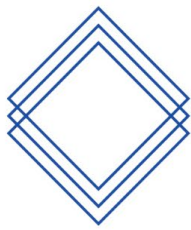

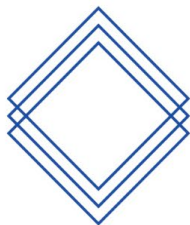

	Note: Create a list. If the records contain telephone numbers and e-mail address, then a separate record must be created to comply with the Privacy Act Search the titles of each lot at Land Victoria if necessary.	Contact the manager, your neighbours or Land Victoria



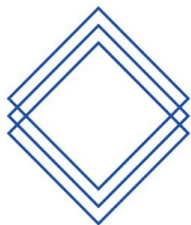

	If the address of each lot owner is different from the address on the title, then advise the lot owner that the title should be updated	
3.	The name of the manager, registration number of the manager and contact details of the manager (if any).	Contact the manager
	Note: If the address for the owners corporation on the plan of subdivision is different then the plan of subdivision should be updated to enable notices to be served on the manager.	Plan of subdivision Contact the manager and Land Victoria
4.	Total lot liability and total lot entitlements	See the plan of subdivision. Contact Land Victoria for a copy of the plan of subdivision.

5.	The lot liability and lot entitlements for each lot affected by the owners corporation	See the plan of subdivision. Contact Land Victoria for a copy of the plan of subdivision.

6.	The basis for the setting of lot liability and lot entitlement (if available)	Contact Land Victoria.
	Note: The basis for the setting of lot liability and lot entitlement will only be required to be recorded at Land Victoria on new owners corporation created after 31 December 2007	
7.	The date of each amendment to the owners corporation rules and the date of the recording of the consolidated rules	Plan of subdivision. Contact Land Victoria

8.	Details of any notices or orders served on the owners corporation by a court or tribunal or under an Act;	Owners corporations records or VCAT decisions. Contact the manager.
	Note: Orders could include breaches of a wide range of legislation including Building, health and planning, occupational health and safety laws.	
9.	Details of contracts, leases and licences entered into by the owners corporation;	Search the owners corporations records.
	Note: It may be necessary to undertake a survey of all owners and occupiers to identify all contracts, leases and licences that the owners corporation has entered into.	
	Details of the insurance policies taken out by the owners corporation including— the name of the insurance company; the number of the insurance policy; the nature of the risk insured; the amount of insurance; the due date of the premium; the date that the premium was last paid.	See owners corporations records. Check minutes of the last annual general meeting. Contact the manager or the insurance company
	Note: This record requires the details of all insurance products/policies taken out by the owners corporation. Not just the insurance cover required by the <i>Owners Corporations Act 2006</i> .
