CVFFD Elysium Privacy Policy

This Privacy Policy ("Policy") applies to the CVFFD Elysium website and matchmaking services. It governs how we collect, use, disclose, and protect personal information provided by users who visit our website and participate in our matchmaking quizzes and services. The Policy applies to CVFFD Elysium LLC ("Company", "us", "we", "event coordinator") for those who complete our free matchmaking forms and/or attend CVFFD Elysium events ("users," "clients," "event attendees," "you" or "your"). For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include https://cvffdelysium.com, any client portals we operate, the presence of CVFFD Elysium on event websites, CVFFD Elysium, its hosts and affiliates. The Company's application offers matchmaking services for relationships, including long-term committed relationships, consensual polyamorous relationships, monogamous relationships, situationships, long-term romantic relationships, friendships, and dating arrangements. By using the Company application, you consent to the data practices described in this statement.

As part of our matchmaking services, CVFFD Elysium collects various types of personal information from clients through our matchmaking form. Our intake forms are secured through encryption so our concierge team will be able to review your files and find personalized matches so other uninvited third parties will not have access to your information. This information helps us tailor our services to find the best matches for our clients. The information we collect includes:

- First and last name
- Preferred contact method for matches
- Picture(s) for dating profile and event
- Fun facts about you for event communication
- Date of birth (to determine age and for verification purposes)
- Gender
- Birthday
- Sexual orientation
- Relationship preferences
- Parenting dynamics
- Relationship roles
- Pictures
- Social media handles (optional)
- Phone number
- Address
- Country
- State/Province
- Town/City
- Zip/Postal code (to find matches nearby)
- Leisure activities
- Languages spoken

- Employment status
- Job role
- Education
- Major in education
- Industry
- Work Type
- Income (this will be kept confidential at all points)
- Height
- Payment information
- Ethnicity
- Religion
- Political affiliation
- Body type
- Lifestyle preferences (e.g., smoking, drinking, tattoos)
- Parenting status (whether you have kids or not)
- Drug or marijuana intake
- Dietary preferences
- Allergies (This should also be communicated on the form, the Host during Check-in at events, and any applicable staff)
- Sleeping preferences
- Zodiac sign
- Enneagram type
- Personality type
- Opinions on controversial topics (e.g., abortion, gun laws)
- Preferences in a partner
- Any other questions located on our free dating or friendship intake forms located on our website

If you purchase the Company's products and services, we collect billing and credit card information to complete the purchase transaction.

Background Checks

Purpose and Scope

CVFFD Elysium strives to provide a safe and reliable platform for individuals seeking social connections, friendships, and potential relationships. As part of this commitment, we may conduct background checks on certain users to verify their eligibility for our services and to enhance the overall safety of our community.

<u>Premium Matches</u>: Prior to any introduction to our premium clients, CVFFD Elysium will conduct a background check on interested parties. By agreeing to be matched with a premium client, you explicitly consent to such a check.

<u>Free Clients</u>: CVFFD Elysium may, at its sole discretion, request random background checks when free clients wish to meet each other. If you do not consent to a background check, you will be unable to proceed with certain matches or events.

Types of Information Collected

Background checks may include:

- Criminal Records: Such as convictions, charges, or pending cases related to violence, assault, stalking, abuse, or other forms of misconduct.
- Publicly Available Data: Including social media or other internet-based searches for relevant information.
- Verification of Identity: We may request identification documents (e.g., driver's license, passport) to confirm your age and identity.

Use of Third-Party Services

We partner with reputable third-party providers (e.g., Checkr) to conduct background checks. These third-party providers may collect and process your personal information solely for the purpose of performing the checks. Any data shared with these providers is handled in accordance with applicable laws, regulations, and contractual agreements that ensure your information is protected.

Data Retention and Disposal

Background check results are kept only for as long as necessary to evaluate a user's eligibility for our services. In general, CVFFD Elysium will retain these records for no more than ten (10) days from the date of receipt, after which they will be securely deleted. If a background check reveals a disqualifying history or concern, CVFFD Elysium reserves the right to keep a record of the finding for the purpose of enforcing a permanent ban on the user.

<u>Disqualification and Removal</u>

Prohibited Histories: Individuals with a verified history of violent crime, assault, stalking, abuse, or other misconduct toward another person will be deemed ineligible. Right to Remove: CVFFD Elysium retains the right to remove a user from our platform and/or decline to provide future services if background checks reveal a concerning or disqualifying history. This may also include barring users from attending our in-person events or accessing any of our digital services.

No Guarantee of Safety

While we take precautions to screen users for violent or assaultive behavior, background checks and other safety measures cannot guarantee an individual's actions or eliminate all risks. We encourage all users to exercise personal judgment and take necessary safety

precautions when interacting with other users online or in person. Any interactions you choose to engage in are ultimately your responsibility.

Accuracy of Information

User Responsibility: You are responsible for providing accurate and current information for any background check. Failure to provide accurate information or to cooperate with the background check process may result in disqualification.

No Warranty on Third-Party Data: CVFFD Elysium does not control the records or data held by external agencies or data sources. We cannot guarantee the completeness or accuracy of information obtained from third-party services.

Changes to This Policy

CVFFD Elysium reserves the right to update or modify this Background Checks policy at any time to reflect changes in law, technology, or our business operations. We will notify you of any significant changes by updating the "Last Updated" date at the top of this Privacy Policy or by other reasonable means.

The Company may also collect anonymous demographic information, such as your:

- Age
- Gender
- Physical attributes
- Race
- Religion
- Political affiliation
- Household income

We do not collect any personal information about you unless you voluntarily provide it to us. You may be required to provide certain personal information to us when you elect to use certain products or services. These may include:

- Registering for an account
- Entering a sweepstakes or contest sponsored by us or one of our partners
- Signing up for special offers from selected third parties
- Sending us an email message
- Submitting your credit card or other payment information when ordering and purchasing products and services

We will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future based on what you choose to share.

Use of Your Personal Information

The Company collects and uses your personal information in the following ways:

- To operate and deliver the services you have requested
- To provide complimentary matchmaking
- To provide you with information, products, or services that you request from us
- To provide you with notices about your account
- To carry out the Company's obligations and enforce our rights arising from any contracts entered into between you and us, including for billing and collection
- To notify you about changes to our website or any products or services we offer or provide through it
- In any other way we may describe when you provide the information
- For any other purpose with your consent
- We use the collected information to provide personalized matchmaking services and to better understand your preferences and compatibility with potential matches.
- The information you provide will be stored in our database and used exclusively by our team for matching purposes. Your information will not be shared with potential matches or third parties without your consent, except as required by law.
- If required by law enforcement, we may disclose your information to comply with legal obligations.

CVFFD Elysium may also use your personally identifiable information to inform you of other products or services available from the Company and its affiliates.

Sharing Information with Third Parties: CVFFD Elysium does not sell, rent, or lease its customer lists to third parties.

The Company may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (email, name, zip code, phone number) is transferred to the third party. The Company may share data with trusted partners to help perform statistical analysis, send you email or postal mail, plan meetups or dates, make reservations, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to the Company, and they are required to maintain the confidentiality of your information.

The Company may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to:

- Conform to the edicts of the law or comply with legal process served on the Company or the site
- Protect and defend the rights or property of the Company
- Act under exigent circumstances to protect the personal safety of users of the Company, or the public

Opt-Out of Disclosure of Personal Information to Third Parties

In connection with any personal information we may disclose to a third party for a business purpose, you have the right to know the categories of personal information that we disclosed about you for a business purpose.

You have the right under the California Consumer Privacy Act of 2018 (CCPA) and certain other privacy and data protection laws, as applicable, to opt out of the disclosure of your personal information. If you exercise your right to opt out of the disclosure of your personal information, we will refrain from disclosing your personal information unless you subsequently provide express authorization for the disclosure of your personal information. Right to Deletion

Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

- Delete your personal information from our records
- Direct any service providers to delete your personal information from their records

Please note that we may not be able to comply with requests to delete your personal information if it is necessary to:

- Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity, or prosecute those responsible for that activity

- Debug to identify and repair errors that impair existing intended functionality
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law
- Comply with the California Electronic Communications Privacy Act
- Engage in public or peer-reviewed scientific, historical, or statistical research in
 the public interest that adheres to all other applicable ethics and privacy laws
 when our deletion of the information is likely to render impossible or seriously
 impair the achievement of such research, provided we have obtained your
 informed consent
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us
- Comply with an existing legal obligation
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information

Specific Regulations by Country

- United States: Your data will be protected under the California Consumer Privacy Act (CCPA) and other applicable state laws.
- Canada: Your data will be managed in accordance with the Personal Information Protection and Electronic Documents Act (PIPEDA).
- United Kingdom and Ireland: Your data will be protected under the General Data Protection Regulation (GDPR) and the Data Protection Act 2018.
- Netherlands: Your data will be managed in accordance with the GDPR and the Dutch Data Protection Authority (Autoriteit Persoonsgegevens).
- Australia: Your data will be protected under the Privacy Act 1988 and the Australian Privacy Principles (APPs).
- New Zealand: Your data will be managed in accordance with the Privacy Act 2020.

Your Rights

You have the right to access, correct, or delete your personal information at any time. To exercise these rights, please contact us at support@cvffdelysium.com with your request. We will respond to your request in accordance with applicable data protection laws.

Age Restrictions and Regulations

CVFFD Elysium is committed to protecting the privacy of all individuals. In compliance with the Children's Online Privacy Protection Act (COPPA), we do not knowingly collect, store, or use personally identifiable information from children under the age of 13. Any use of our services by children under 13 is strictly prohibited. Furthermore, our services are designed for adults, and we do not knowingly collect personally identifiable information from anyone under the age of 18. It is our policy not to engage with or offer matchmaking services to individuals who are under the age of 18, regardless of their country of origin. CVFFD Elysium requires all clients to confirm that they are 18 years of age or older at the time of registration. We reserve the right to verify a client's age by requesting identification before participating in any matchmaking event or meet-up. Failure to provide valid identification upon request may result in the denial of access to our services.

Disconnecting Your Account from Third-Party Websites

You will be able to connect your account to the Google Forms Matchmaking Form. By connecting your Company's account to your third-party account, you acknowledge and agree that you are consenting to the continuous release of information about you to others (in accordance with your privacy settings on those third-party sites). If you do not want information about you, including personally identifying information, to be shared in this manner, do not use this feature. You may disconnect your account from a third-party account at any time.

Opt-Out and Unsubscribe from Third-Party Communications

We respect your privacy and give you an opportunity to opt out of receiving announcements of certain information. Users may opt out of receiving any or all communications from third-party partners of the Company by contacting us here through our email at support@cvffdelysium.com. Email Communications

In order to improve our services, we may receive a notification when you open an email from the Company or click on a link therein.

If you would like to stop receiving marketing or promotional communications via email from the Company, you may opt out of such communications by clicking on the unsubscribe button.

External Data Storage Sites

We may store your data on servers provided by third-party hosting vendors, such as Google, with whom we have contracted.

Data Retention and Integrity

While we employ advanced encryption and data protection measures to ensure the security and confidentiality of your personal information, technical difficulties or storage capacity limits may occasionally result in the unintentional loss or deletion of user profiles and associated data. In such events, we cannot be held liable for the loss of data. If you suspect that your profile may have been impacted by a technical issue or is no longer active, please contact us immediately at support@cvffdelysium.com. We will assist you in verifying the status of your profile and, where possible, restoring your information. Please note that it is the responsibility of each client to confirm the accuracy and activity status of their profile by reaching out to us directly.
