If you have questions regarding how many Continuing Education hours you have or need please call the SC State Board of Cosmetology at 803.896.4588. **Registration for all classes begins at 8 am. Class begins at 9 am and ends at 4:45 pm with an hour for lunch on your own and two 15-minute breaks. You must bring two forms of ID—one of which must be a government issued photo ID AND the other an LLR issued professional license to enter class. Each class is worth 6hrs of CE credit.
