If you have questions about ACSP classes please call 803.345.2909. If you have questions regarding how many Continuing Education hours you have or need please call the SC State Board of Cosmetology at 803.896.4588. Six hour classes include 1 hour for lunch and two 15min. breaks. Four hour classes include one 15min break. **You must bring two forms of ID—one of which must be a government issued photo ID AND the other an LLR issued professional license to enter class.**

HOW DO I REGISTER? Return the enclosed registration form or pay online at www.mycosmetology.org

- Mailed forms should be POSTMARKED by the deadline indicated for the class.
- You may pay for your pre-registration with cash, check, money order made out to ACSP OR online at www.mycosmetology.org
- We do not accept credit cards over the phone, please pay online.
- **NO REFUNDS and NO TRANSFERS to another class unless we hear from you BEFORE class. (Leave a voice mail)**
- If you do not pre-register by the deadline, space may be available at the door on the day of class first come first served.

***IMPORTANT INFO** You will not receive any confirmation of registration. Your cancelled check will serve as assurance that we received your money. Your name will be on the sign in sheet when you arrive. If you would still like to confirm receipt of your registration please feel free to call us at 803.345.2909. ACSP will charge a \$25 fee for any bounced checks or stop payments. This fee must be paid before you can attend any future ACSP classes. Don't be late to class—we CAN NOT admit you to class after 9 AM! Remember, you must receive your certificate from USC before you can be considered compliant with your continuing education requirements for renewal of your license. If you don't receive your certificate within 4 weeks we suggest you contact USC at 803-777-9440.

Pandemic FAQs

MASKS/DISTANCING—We ask everyone who registers for our classes to be flexible/prepared for “distanced” seating arrangements and potential mask requirements. **BRING YOUR OWN MASK!!!!** Please know that ACSP will work to protect while we educate. We will defer to the policies in place at our class venues (hotels, etc).

PRE-REGISTER—ACSP HIGHLY RECOMMENDS PRE-REGISTRATION! Due to the distanced seating/lower occupancies we recommend registering for class ahead of time! Seats at the door will be very limited if available at all.

If your VOA (First, Middle, Last) doesn't look exactly as it appears on your license then USC will send it back to the provider delaying processing of the entire course and charging your provider (ACSP) a fee. ACSP reserves the right to pass that fee along to any person who submits a VOA that has been incorrectly completed.
