If you aren't sure if you need a class please call the SC State Board of Cosmetology at 803.896.4588 or log in to your account at LLR's website llr.sc.gov/cosmo/. You can also change your address, print a copy of your license and so much more at this website! Classes include one 15min. break. **You must bring two forms of ID—one of which must be a government issued photo ID AND the other an LLR issued professional license to enter class. Please arrive at 7:45 AM.**

HOW DO I REGISTER? Return the enclosed registration form or pay online at www.mycosmetology.org

- Mailed forms should be POSTMARKED by the "Register By" date indicated for the class.
- You may pay for your pre-registration with cash, check, money order made out to ACSP OR online at www.mycosmetology.org
- We do not accept credit cards over the phone, please pay online at www.mycosmetology.org.
- **NO REFUNDS and NO TRANSFERS to another class unless we hear from you BEFORE class. (Leave a voice mail or send an email)**
- If you do not pre-register by the deadline, space may be available at the door on the day of class first come first served.

***IMPORTANT INFO** You will not receive any confirmation of registration. Your cancelled check will serve as assurance that we received your money. Your name will be on the sign in sheet when you arrive. If you would still like to confirm receipt of your registration please feel free to call us at 803.345.2909. ACSP will charge a \$25 fee for any bounced checks or stop payments. This fee must be paid before you can attend any future ACSP classes. Don't be late to class—we CAN NOT admit you to class late! Remember, you must receive your certificate from USC before you can be considered compliant with your continuing education requirements for renewal of your license. If you don't receive your certificate within 4 weeks we suggest you contact USC at 803-777-9440.

Make sure you complete your VOA at the end of class using exactly the info on your license! If your VOA (First, Middle, Last) doesn't look exactly as it appears on your license then USC will send it back to the provider delaying processing of the entire course and charging your provider (ACSP) a fee. ACSP reserves the right to pass that fee along to any person who submits a VOA that has been incorrectly completed.

RC, NT, ES and Instructors with an ACTIVE license only need 4 hours to renew in 2025. If your license has been lapsed in any way your requirements may be different and you should check with the State Board of Cosmetology!
