She displayed her commitment to civic duty by serving faithfully as an Election Inspector prior to the onset of Covid. It’s not always “all work and no play” for Marie. She is one of the last surviving members of a group of women friends who have been meeting together every month since college. As her children agree, “She has more of a social life that the two of us put together.”

Marie met her husband, Leo Zafron at a dance in 1966 where it was love at first sight. They married in 1967 and were devoted to each other until his sudden and unexpected death in 2005.

They successfully parented two children, Michelle, who is an academic librarian and Mark, who is an engineer. The children’s education and wellbeing were paramount in their lives. A life-threatening health crisis struck Mark as a young man. The family did not have health insurance, but Marie was tireless in assuring that her son had the health care he required, navigating the maze of social workers and hospital bills. Family notes tell us that she is an excellent cook, especially being able to make tasty and nutritious meals out of minimal provisions. Could this be an “Old School” trait that developed as a child growing up in the 1930’s & 40’s?

We salute this vibrant nonagenarian! Thank you, Marie, for being such a marvelous role model of “Old School” values. You are greatly admired and respected. May you enjoy many more years of good health and happiness.

Health News

I have addressed the topic of memory before in this column, particularly in reference to Alzheimer's disease. Not as severe as Alzheimer's, but still a troubling situation to experience is Brain Fog. Brain Fog is not a medical condition in its own right, but instead the term refers to certain symptoms that can affect a person's ability to think. These symptoms include confusion, difficulty focusing, a lack of mental clarity, and memory issues. Sound familiar? I think most of us could say we have experienced one or more of them, and we associate them with the aging process. However, if they persist or interfere with you living your best life, you may want to speak to your medical professional about them.

There is no test for Brain Fog. Instead, some medical detective work needs to be done to determine the underlying cause of these symptoms. Brain Fog has been associated with stress, sleep issues, diet, hormonal changes, and medications. It can also be linked to other medical conditions, such as anemia, depression, diabetes, dehydration, and Long Covid-19.

Treatment could be as simple as getting more sleep or more involved, like changing a medication. Treatment might involve some trial-and-error attempts.

A boat ride along the St Lawrence River will take you to Dark Island to enjoy a guided tour of the Singer Castle which was built by the Bourne Family in 1905. Later the boat will take you to Heart Island for a self-guided tour of Boldt Castle, erected for \$2.5 million in the early 1900's, and currently generates over \$46 million annually in regional economic activity. RENY Annual Convention- October 15-17, 2025

The State Annual Meeting (RENY) Retired Educators of New York, took place in Verona, New York. RENY has 10 zones and over 9000 members. The State has been incorporated since 1955.

Our Western Zone, which has 5 counties (Chautauqua, Cattaraugus, Erie, Genesee, and Niagara) represents over 2000 members. One of our yearly highpoints is the Annual Meeting which this year had 24 Western Zone delegates attending and voting on the following 2 Bylaws:

Proposition RMFBOD (Required Meetings for Board of Directors) 2025:

The Board of Directors will meet as necessary to fulfil its responsibilities. At least two face-to-face meetings shall be held annually. Additionally, electronic meetings are authorized in accordance with the parliamentary authority identified in Article XVII of these bylaws.

Proposition AMAWAC (Annual Meeting, Annual Workshop, and Annual Convention) 2025:

The Annual Convention of the Association consists of the Annual Workshop and the Annual Meeting plus other activities of the Association at the time the Annual Convention is held.

Both propositions passed by a “yea” vote of 112 delegates and are now part of our Bylaws

Western Zone was allotted 20 zone delegates and 4 at large delegates for a total of 24 WZ delegates this year. The number of delegates is based on our WZ membership as of July 1, each year.

Western Zone also has newly elected state officers. They are Judy Farmer, Senior State VP; Carol Cascio, State Secretary; John Cardarella, State Nominations Chair; and Michelle Claus, State VP for Membership.

A friendly Trivia Night Competition was held the second night. WZ had 3 teams with 6 members on each team. The Southtowns’ Legends, one of the WZ teams, came in second place. Congratulations!

When we are not at the RENY or our Western Zone Conference, we are spending time donating and gathering for our retirees and communities. Spending much of our time on Community service activities. Our units implement county-wide service projects, too. We collect pajamas, coats, hats, gloves, socks, toiletries, purses, wallets and several other types of clothing. In September, we collect books for Buffalo school children, as well.
