

# TERMS AND CONDITIONS



These terms and conditions apply to the following goods and services supplied by MV Expo Ltd (Company number: 11336865):

- (a) Exhibition stand design and build services
- (b) Event services
- (c) Sale of display products
- (d) Hire of display products

## 1. Definitions and Interpretation

1.1 In this Contract the following expressions shall have the following meanings:

**"Business Day"** means a day (other than a Saturday or Sunday) on which clearing banks are open for business in the City of London (other than solely for trading or settlement of the Euro)

**"Commencement Date"** means the date stated as such within clause 2.2 of the Order

**"Contract"** means the contract between MV Expo and the Client for the supply of Goods and/or Services in accordance with these Conditions

**"Client"** the person or firm who purchases the Goods and/or Services from MV Expo or hires Goods from them

**"Deliverables"** the deliverables set out in the Order

**"Delivery Location"** has the meaning set out in clause 4.2

**"Interest"** means the rate of 2% above the Bank of England base rate which is current at the date the Client or the Contractor (as the case may be) becomes overdue on a payment

**"MV Expo"** MV Expo Limited registered in England and Wales with company number 11336865 and the registered address of Unit 4, Bay 2, Walton Farm, Walton Lane, Bosham, Chichester, England, PO18 8QB

**"Force Majeure Event"** has the meaning given to it in clause 15.1

**"Goods"** the products (or any part of them) set out in the Order, be they goods designed or sold by MV Expo

**"Goods Specification"** any specification for the Goods, in respect of exhibition stand and design services, including any relevant plans or drawings that are agreed in writing by the Client and MV Expo

**"Hired Goods"** the products hired from MV Expo by the Client in accordance with the Conditions.

**"Intellectual Property Rights"** patents, rights to inventions, copyright and related rights, trade marks, business names and domain names, rights in get-up, goodwill and the right to sue for passing off, rights in designs, database rights, rights to use, and protect the confidentiality of, confidential information (including know-how), and all other intellectual property rights, in each case whether registered or unregistered and including all applications and rights to apply for and be granted, renewals or extensions of, and rights to claim priority from, such rights and all similar or equivalent rights or forms of protection which subsist or will subsist now or in the future in any part of the world

**"Order"** the Client's order for the supply of Goods and/or Services or the hire of Goods

**“Rental Period”** the period of hire as set out in clause 8

**“Services”** the services, be they design and build services or general event services, including the deliverables supplied by MV Expo to the Client as set out in the Service Specification below.

**“Service Specification”** the description or specification for the Services, be they design and build services or general event services, provided in writing by MV Expo to the Client

**“Supplier Materials”** has the meaning set out in clause 9.9.1(f).

1.2 Construction. In these Conditions, the following rules apply:

- (a) a **person** includes a natural person, corporate or unincorporated body (whether or not having separate legal personality);
- (b) a reference to a party includes its personal representatives, successors or permitted assigns;
- (c) a reference to a statute or statutory provision is a reference to such statute or statutory provision as amended or re-enacted. A reference to a statute or statutory provision includes any subordinate legislation made under that statute or statutory provision, as amended or re-enacted;
- (d) any phrase introduced by the terms **including, include, in particular** or any similar expression shall be construed as illustrative and shall not limit the sense of the words preceding those terms; and
- (e) a reference to **writing** or **written** includes faxes and emails.

## 2. Basis of Contract

2.1 The Order constitutes an offer by the Client to purchase Goods and/or Services or hire the Hired Goods in accordance with these Conditions

2.2 The Order shall only be deemed to be accepted when MV Expo issues a written acceptance of the Order, or varies the Order and such variation is accepted by the Client, at which point and on which date the Contract shall come into existence (the “Commencement Date”)

2.3 The Contract constitutes the entire agreement between the parties. The Client acknowledges that it has not relied on any statement, promise, representation, assurance or warranty made or given by or on behalf of MV Expo which is not set out in the Contract

2.4 Any samples, drawings, descriptive matter or advertising issued by MV Expo and any descriptions of the Goods or illustrations or descriptions of the Services contained in MV Expo’ marketing are issued or published for the sole purpose of giving an approximate idea of the Services and/or Goods described in them. They shall not form part of the Contract or have any contractual force

2.5 These Conditions apply to the Contract to the exclusion of any other terms that the Client seeks to impose or incorporate, or which are implied by trade, custom, practice or course of dealing

2.6 Any quotation given by MV Expo shall not constitute an offer, and is only valid for a period of 30 Business Days from its date of issue

2.7 All of these Conditions shall apply to the supply of Goods and Services and hire of the Hire

Goods except where application to one or the other is specified

### **3. Goods**

3.1 The Goods are described in the case of Goods designed by MV Expo for the Client, the Goods Specification

3.2 To the extent that the Goods are to be manufactured in accordance with a Goods Specification supplied by the Client, the Client shall indemnify MV Expo against all liabilities, costs, expenses, damages and losses (including any direct, indirect or consequential losses, loss of profit, loss of reputation and all interest, penalties and legal and other professional costs and expenses) suffered or incurred by MV Expo in connection with any claim made against MV Expo for actual or alleged infringement of a third party's intellectual property rights arising out of or in connection with the MV Expo' use of the Goods Specification. This clause 3.2 shall survive termination of the Contract

3.3 MV Expo reserves the right to amend the Goods Specification if required by any applicable statutory or regulatory requirements

### **4. Delivery of Goods**

4.1 MV Expo shall ensure that each delivery of the Goods and/or Hired Goods are accompanied by a delivery note which shows the date of the Order, all relevant Client and MV Expo reference numbers, the type and quantity of the Goods (including the code number of the Goods, where applicable), special storage instructions (if any) and, if the Order is being delivered by instalments, the outstanding balance of Goods remaining to be delivered

4.2 MV Expo shall deliver the Goods and/or Hired Goods to the location set out in the Order or such other location as the parties may agree, this could include MV Expo's own premises (the "Delivery Location") at any time after MV Expo notifies the Client that the Goods are ready

4.3 Delivery of the Goods and/or Hired Goods shall be completed on the Goods' arrival at the Delivery Location

4.4 Any dates quoted for delivery of the Goods and/or Hired Goods are approximate only, and the time of delivery is not of the essence. MV Expo shall not be liable for any delay in delivery of the Goods and/or Hired Goods that is caused by a Force Majeure Event or the Client's failure to provide MV Expo with adequate delivery instructions or any other instructions that are relevant to the supply of the Goods and/or Hired Goods

4.5 If MV Expo fails to deliver the Goods and/or Hired Goods, its liability shall be limited to the costs and expenses incurred by the Client in obtaining replacement goods of similar description and quality in the cheapest market available, less the price of the Goods and/or Hired Goods. MV Expo shall have no liability for any failure to deliver the Goods and/or Hired Goods to the extent that such failure is caused by a Force Majeure Event the Client's failure to provide MV Expo with adequate delivery instructions for the Goods or any relevant instruction related to the supply of the Goods and/or Hired Goods

4.6 If the Client fails to accept or take delivery of the Goods within 10 Business Days of MV Expo notifying the Client that the Goods are ready, then except where such failure or delay is caused

by a Force Majeure Event or by MV Expo' failure to comply with its obligations under the Contract in respect of the Goods:

- (a) delivery of the Goods shall be deemed to have been completed at 9.00am on the 7th Business Day following the day on which MV Expo notified the Client that the Goods were ready; and
- (b) MV Expo shall store the Goods until delivery takes place, and charge the Client for all related costs and expenses (including insurance)

4.7 If 20 Business Days after MV Expo notified the Client that the Goods were ready for delivery the Client has not accepted delivery of them, MV Expo may resell or otherwise dispose of part or all of the Goods and, after deducting reasonable storage and selling costs, account to the Customer for any excess over the price of the Goods or charge the Customer for any shortfall below the price of the Goods

4.8 MV Expo may deliver the Goods by instalments, which shall be invoiced and paid for separately. Each instalment shall constitute a separate contract. Any delay in delivery or defect in an instalment shall not entitle the Client to cancel any other instalment

### 5. Quality of Goods

5.1 MV Expo warrants that on delivery the Goods shall:

- (a) conform in all material respects with their description or the Goods Specification or, in the case of Goods designed by MV Expo for the Client, the Goods Specification; and
- (b) be free from material defects in design, material and workmanship.

5.2 Subject to clause 5.3, if:

- (a) the Client gives notice in writing within 14 days of delivery that some or all of the Goods do not comply with the warranty set out in clause 5.1;
- (b) MV Expo is given a reasonable opportunity of examining such Goods; and
- (c) the Client (if asked to do so by MV Expo) returns such Goods to the MV Expo' place of business at the Client's cost

MV Expo shall, at its option, repair or replace the defective Goods, or refund the price of the defective Goods in full.

5.3 MV Expo shall not be liable for the Goods' failure to comply with the warranty in clause 5.1 if:

- (a) the Client makes any further use of such Goods after giving a notice in accordance with clause 5.2;
- (b) the defect arises because the Client failed to follow the MV Expo' oral or written instructions as to the storage, installation, commissioning, use or maintenance of the Goods or (if there are none) good trade practice;
- (c) the defect arises as a result of MV Expo following any drawing, design or Goods Specification supplied by the Client;
- (d) the Client alters or repairs such Goods without the written consent of MV Expo;
- (e) the defect arises as a result of fair wear and tear, wilful damage, negligence, or abnormal working conditions;
- (f) the Goods differ from their description or the Goods Specification as a result of changes

made to ensure they comply with applicable statutory or regulatory standards.

5.4 Except as provided in this clause 5, MV Expo shall have no liability to the Client in respect of the Goods' failure to comply with the warranty set out in clause 5.1

5.5 The terms of these Conditions shall apply to any repaired or replacement Goods supplied by Exhibition Service under clause 5.2

### **6. Title and Risk**

6.1 The risk in the Goods shall pass to the Client on completion of delivery

6.2 Title to the Goods shall not pass to the Client until MV Expo receives payment in full (in cleared funds) for the Goods and any other goods that MV Expo has supplied to the Client in respect of which payment has become due, in which case title to the Goods shall pass at the time of payment of all such sums

6.3 Until title to the Goods has passed to the Client, the Client shall:

- (a) not remove, deface or obscure any identifying mark or packaging on or relating to the Goods;
- (b) maintain the Goods in satisfactory condition and keep them insured against all risks for their full price on MV Expo' behalf from the date of delivery;
- (c) notify MV Expo immediately if it becomes subject to any of the events listed in clause 14.2(b) to clause 14.2(m); and
- (d) give MV Expo such information relating to the Goods as MV Expo may require from time to time

6.4 If before title to the Goods passes to the Client the Client becomes subject to any of the events listed in clause 14.2(b) to clause 14.2(m), then, without limiting any other right or remedy MV Expo may have:

- (a) the Client's right to resell Goods or use them in the ordinary course of its business ceases immediately; and
- (b) MV Expo may at any time:
  - (i) require the Client to deliver up all Goods in its possession which have not been resold, or irrevocably incorporated into another product; and
  - (ii) if the Client fails to do so promptly, enter any premises of the Client or of any third party where the Goods are stored in order to recover them

### **7. Supply of Services**

7.1 MV Expo shall provide the Services to the Client in accordance with the Service Specification in all material respects

7.2 MV Expo shall use all reasonable endeavours to meet any performance dates for the Services, but any such dates shall be estimates only and time shall not be of the essence for the performance of the Services

7.3 MV Expo shall have the right to make any changes to the Services which are necessary to comply with any applicable law or safety requirement, or which do not materially affect the

nature or quality of the Services, and MV Expo shall notify the Client in any such event

7.4 MV Expo warrants to the Client that the Services will be provided using reasonable care and skill

7.5 Any cancellation of Services must be submitted in writing at the earliest opportunity.

Dependent upon the time of cancellation, the following charges will apply:

(a) In respect of the supply of Services: at the point of cancellation, all project management and expenses payments to date will apply. In the event that a cancellation notification is received less than 60 days prior to the start of the provision of Services, full charges of Services and all administration/project management charges will apply.

(b) In respect of Hired Goods:

(i) 100% payment if cancelled 0 - 7 days prior to the event;

(ii) 75% payment if cancelled 8 -14 days prior to the event;

(iii) 50% payment if cancelled 15 - 21 days prior to the event;

and

(iv) 25% payment if cancelled 22 - 28 days prior to the event.

Any deposits paid are non-refundable.

### **8. Goods Hired**

8.1 MV Expo shall hire the Hired Goods to the Client subject to the terms of the Conditions and, in particular, this clause 8

8.2 The Rental Period shall last for the period specified in the Order unless this agreement is terminated earlier in accordance with clause 14

8.3 The Hired Goods shall at all times remain the property of MV Expo, and the Client shall have no right, title or interest in or to the Hired Goods (save the right to possession and use of the Goods subject to the terms of the Conditions)

8.4 The risk of loss, theft, damage or destruction of the Hired Goods shall pass to the Client on Delivery. The Hired Goods shall remain at the sole risk of the Client during the Rental Period and any further term during which the Hired Goods are in the possession, custody or control of the Client (the "Risk Period") until such time as the Hired Goods are returned to MV Expo. During the Rental Period and the Risk Period, the Client shall, at its own expense, obtain and maintain the following insurances:

(a) insurance of the Hired Goods to a value not less than the full replacement value comprehensively against all usual risks of loss, damage or destruction by fire, theft or accident, and such other risks as MV Expo may from time to time nominate in writing;

(b) insurance for such amounts as a prudent owner or operator of the Hired Goods would insure for, or such amount as MV Expo may from time to time reasonably require, to cover any third party or public liability risks of whatever nature and however arising in connection with the Hired Goods; and

(c) insurance against such other or further risks relating to the Hired Goods as may be required by law, together with such other insurance as MV Expo may from time to time consider reasonably necessary and advise to the Client

8.5 The Client shall give immediate written notice to MV Expo in the event of any loss, accident

or damage to the Hired Goods arising out of or in connection with the Client's possession or use of the Hired Goods

8.6 If the Client fails to effect or maintain any of the insurances required under this agreement, MV Expo shall be entitled to effect and maintain the same, pay such premiums as may be necessary for that purpose and recover the same as a debt due from the Client

8.7 The Client shall, at all times whilst in possession of the Hired Goods:

- (a) ensure that the Hired Goods are kept in a suitable environment;
- (b) take such steps as may be necessary to ensure, so far as is reasonably practicable, that the Hired Goods are at all times safe and without risk to health when it being set, used, cleaned or maintained by a person at work;
- (c) make no alteration to the Hired Goods and shall not remove any existing component(s) from the Hired Goods;
- (d) keep MV Expo fully informed of all material matters relating to the Hired Goods;
- (e) permit MV Expo or its duly authorised representative to inspect the Hired Goods at all reasonable times and shall grant reasonable access for such inspection;
- (f) not, without the prior written consent of MV Expo, part with control of (including for the purposes of repair or maintenance), sell or offer for sale, underlet or lend the Hired Goods or allow the creation of any mortgage, charge, lien or other security interest in respect of them;
- (g) not without the prior written consent of MV Expo, attach the Hired Goods to any land or building so as to cause the Hired Goods to become a permanent or immovable fixture on such land or building. If the Hired Goods do become affixed to any land or building then the Hired Goods must be capable of being removed without material injury to such land or building and the Client shall repair and make good any damage caused by the affixation or removal of the Hired Goods from any land or building and indemnify MV Expo against all losses, costs or expenses incurred as a result of such affixation or removal;
- (h) not do or permit to be done any act or thing which will or may jeopardise the right, title and/or interest of MV Expo in the Hired Goods and, where the Hired Goods have become affixed to any land or building, the Client must take all necessary steps to ensure that MV Expo may enter such land or building and recover the Hired Goods both during the term of this agreement and for a reasonable period thereafter;
- (i) not suffer or permit the Hired Goods to be confiscated, seized or taken out of its possession or control under any distress, execution or other legal process, but if the Hired Goods are so confiscated, seized or taken, the Client shall notify MV Expo and the Client shall at its sole expense use its best endeavours to procure an immediate release of the Hired Goods and shall indemnify MV Expo on demand against all losses, costs, charges, damages and expenses incurred as a result of such confiscation;
- (j) not use the Hired Goods for any unlawful purpose;
- (k) ensure that at all times the Hired Goods remain identifiable as being MV Expo' property and wherever possible shall ensure that a visible sign to that effect is attached to the Hired Goods; and
- (l) deliver up the Hired Goods at the end of the Rental Period or on earlier termination at such address as MV Expo requires, or if necessary allow MV Expo or its representatives

access to any premises where the Hired Goods are located for the purpose of removing the Hired Goods. 8.8 The Client acknowledges that MV Expo shall not be responsible for any loss of or damage to the Hired Goods arising out of or in connection with any negligence, misuse, mishandling of the Hired Goods or otherwise caused by the Client or its officers, employees, agents and contractors, and the Client undertakes to indemnify MV Expo on demand against the same, and against all losses, liabilities, claims, damages, costs or expenses of whatever nature otherwise arising out of or in connection with any failure by the Client to comply with the Conditions.

### 9. Client's Obligations

9.1 The Client shall:

- (a) ensure that the terms of the Order and (if submitted by the Client) the Goods Specification are complete and accurate;
- (b) co-operate with MV Expo in all matters relating to the Services;
- (c) provide MV Expo, its employees, agents, consultants and subcontractors, with access to the Client's premises, office accommodation and other facilities as reasonably required by MV Expo to provide the Services;
- (d) provide MV Expo with such information and materials as MV Expo may reasonably require to supply the Services, and ensure that such information is accurate in all material respects;
- (e) obtain and maintain all necessary licences, permissions and consents which may be required for the Services before the date on which the Services are to start; and
- (f) keep and maintain all materials, equipment, documents and other property of MV Expo (the "Supplier Materials") at the Client's premises in safe custody at its own risk, maintain the Supplier Materials in good condition until returned to MV Expo, and not dispose of or use the Supplier Materials other than in accordance with the MV Expo' written instructions or authorisation

9.2 If MV Expo' performance of any of its obligations in respect of the Services is prevented or delayed by any act or omission by the Client or failure by the Client to perform any relevant obligation ("Client Default"):

- (a) MV Expo shall without limiting its other rights or remedies have the right to suspend performance of the Services until the Client remedies the Client Default, and to rely on the Client Default to relieve it from the performance of any of its obligations to the extent the Client Default prevents or delays MV Expo' performance of any of its obligations;
- (b) MV Expo shall not be liable for any costs or losses sustained or incurred by the Client arising directly or indirectly from the MV Expo' failure or delay to perform any of its obligations as set out in this clause 9.2; and
- (c) the Client shall reimburse MV Expo on written demand for any costs or losses sustained or incurred by MV Expo arising directly or indirectly from the Client Default

### 10. Charges and Payment

10.1 The price for the sale of Goods shall be MV Expo' quoted price at the date of delivery. The price of the Goods is exclusive of all costs and charges of packaging, insurance, transport of the Goods. In the event that a credit account has not been approved, payment will become due before the release of goods

10.2 The charges for Services shall be on a time and materials basis:

- (a) the price quoted for Services shall be MV Expo' quoted price for the duration of the event/exhibition for which they are intended, up to a maximum of 7 days. The Client shall pay such deposit as MV Expo shall direct
- (b) the quoted price is based on the Service Specification given at the time of the latest quotation
- (c) Should additional work be required, a further quotation will be provided
- (d) Any additional post-event/exhibition items invoiced will be required to be paid Immediately

10.3 The rental payments for Hired Goods:

- (a) Shall be MV Expo' quoted prices at the date of delivery (the "Rental Payments")
- (b) The Client shall pay the Rental Payments to MV Expo in return for the Hired Goods
- (c) In addition to the Rental Payments, the Client may also be required to pay MV Expo a deposit against default by the Client of payment of any Rental Payments or any loss of or damage caused to the Hired Goods. In the event that a deposit is required, this will be set out in the quotation. If the Client fails to pay any of the Rental Payments, or causes any loss or damage to the Hired Goods (in whole or in part), MV Expo shall be entitled to apply the deposit against such default, loss or damage

10.4 MV Expo reserves the right to:

- (a) increase the charges for the Services, provided that such charges cannot be increased more than once in any 12 month period. MV Expo will give the Client written notice of any such increase 1 month before the proposed date of the increase. If such increase is not acceptable to the Client, it shall notify MV Expo in writing within 2 weeks of the date of MV Expo' notice and MV Expo shall have the right without limiting its other rights or remedies to terminate the Contract by giving 2 weeks' written notice to the Client; and
- (b) increase the price of the Goods or the Hired Goods, by giving notice to the Client at any time before delivery, to reflect any increase in the cost of the Goods to MV Expo that is due to:
  - (i) any factor beyond the control of MV Expo (including foreign exchange fluctuations, increases in taxes and duties, and increases in labour, materials and other manufacturing costs);
  - (ii) any request by the Client to change the delivery date(s), quantities or types of Goods ordered, or the Goods Specification; or
  - (iii) any delay caused by any instructions of the Client in respect of the Goods or failure of the Client to give MV Expo adequate or accurate information or instructions in respect of the Goods

10.5 In respect of Goods, MV Expo shall invoice the Client on or at any time after completion of

delivery

10.6 In respect of Services, MV Expo shall invoice the Client at the point of installation or at a chosen point prior to installation (subject to MV Expo's absolute discretion and as outlined in the quotation), whichever is sooner

10.7 The Client shall pay each invoice submitted by MV Expo:

- (a) within 30 days of the date of the invoice; and
- (b) in full and in cleared funds to a bank account nominated in writing by MV Expo, and time for payment shall be of the essence of the Contract

10.8 All amounts payable by the Client under the Contract are exclusive of amounts in respect of value added tax chargeable from time to time (VAT). Where any taxable supply for VAT purposes is made under the Contract by MV Expo to the Client, the Client shall, on receipt of a valid VAT invoice from MV Expo, pay to MV Expo such additional amounts in respect of VAT as are chargeable on the supply of the Services or Goods or Hired Goods at the same time as payment is due for the supply of the Services or Goods

10.9 The preferred method of payment shall be direct transfer

10.10 If the Client fails to make any payment due to MV Expo under the Contract by the due date for payment, then the Client shall pay interest on the overdue amount at the rate of 4% per annum above the Bank of England's base rate from time to time. Such interest shall accrue on a daily basis from the due date until actual payment of the overdue amount, whether before or after judgment. The Client shall pay the interest together with the overdue amount

10.11 The Client shall pay all amounts due under the Contract in full without any set-off, counterclaim, deduction or withholding except as required by law. MV Expo may, without limiting its other rights or remedies, set off any amount owing to it by the Client against any amount payable by MV Expo to the Client

10.12 A surcharge shall be applied to payments made by AMEX, credit or commercial debit card and personal debit card payments. Such surcharge is subject to change and confirmation of the exact amount will be provided upon request

### **11. Intellectual Property Rights**

11.1 All Intellectual Property Rights in or arising out of or in connection with the Goods, the Hired Goods and the Services, including the design services, shall be owned by MV Expo. MV Expo hereby grants the Client a perpetual royalty free licence to use these Intellectual Property Rights, subject to payment of its invoices

11.2 The Client acknowledges that, in respect of any third party Intellectual Property Rights in the Services, the Client's use of any such Intellectual Property Rights is conditional on MV Expo obtaining a written licence from the relevant licensor on such terms as will entitle MV Expo to license such rights to the Client

11.3 All Supplier Materials are the exclusive property of MV Expo

### **12. Confidentiality**

12.1 A party (receiving party) shall keep in strict confidence all technical or commercial knowhow,

specifications, inventions, processes or initiatives which are of a confidential nature and have been disclosed to the receiving party by the other party (disclosing party), its employees, agents or subcontractors, and any other confidential information concerning the disclosing party's business, its products and services which the receiving party may obtain. The receiving party shall only disclose such confidential information to those of its employees, agents and subcontractors who need to know it for the purpose of discharging the receiving party's obligations under the Contract, and shall ensure that such employees, agents and subcontractors comply with the obligations set out in this clause as though they were a party to the Contract. The receiving party may also disclose such of the disclosing party's confidential information as is required to be disclosed by law, any governmental or regulatory authority or by a court of competent jurisdiction. This clause shall survive termination of the Contract

### **13. Limitation of Liability: THE CLIENT'S ATTENTION IS PARTICULARLY DRAWN TO THIS CLAUSE**

13.1 Nothing in these Conditions shall limit or exclude MV Expo' liability for:

- (a) death or personal injury caused by its negligence, or the negligence of its employees, agents or subcontractors;
- (b) fraud or fraudulent misrepresentation;
- (c) breach of the terms implied by section 2 of the Supply of Goods and Services Act 1982 (title and quiet possession);
- (d) breach of the terms implied by section 12 of the Sale of Goods Act 1979 (title and quiet possession); or
- (e) defective products under the Consumer Protection Act 1987

13.2 Subject to clause 13.1:

- (a) MV Expo shall under no circumstances whatever be liable to the Client, whether in contract, tort (including negligence), breach of statutory duty, or otherwise, for any loss of profit, or any indirect or consequential loss arising under or in connection with the Contract; and
- (b) MV Expo' total liability to the Client in respect of all other losses arising under or in connection with the Contract, whether in contract, tort (including negligence), breach of statutory duty, or otherwise, shall in no circumstances exceed the fees payable or paid to MV Expo in accordance with these Conditions

13.3 The terms implied by sections 13 to 15 of the Sale of Goods Act 1979 and the terms implied by sections 3 to 5 of the Supply of Goods and Services Act 1982 are, to the fullest extent permitted by law, excluded from the Contract

13.4 This clause 13 shall survive termination of the Contract

### **14. Termination**

14.1 Without limiting its other rights or remedies MV Expo may terminate the Contract by giving the Client not less than 1 months' written notice

14.2 Without limiting its other rights or remedies, each party may terminate the Contract with

immediate effect by giving written notice to the other party if:

- (a) the other party commits a material breach of its obligations under this Contract and (if such breach is remediable) fails to remedy that breach within 21 days after receipt of notice in writing to do so;
- (b) the other party suspends, or threatens to suspend, payment of its debts or is unable to pay its debts as they fall due or admits inability to pay its debts or (being a company or limited liability partnership) is deemed unable to pay its debts within the meaning of section 123 of the Insolvency Act 1986 or (being an individual) is deemed either unable to pay its debts or as having no reasonable prospect of so doing, in either case, within the meaning of section 268 of the Insolvency Act 1986 or (being a partnership) has any partner to whom any of the foregoing apply;
- (c) the other party commences negotiations with all or any class of its creditors with a view to rescheduling any of its debts, or makes a proposal for or enters into any compromise or arrangement with its creditors other than (where a company) for the sole purpose of a scheme for a solvent amalgamation of that other party with one or more other companies or the solvent reconstruction of that other party;
- (d) a petition is filed, a notice is given, a resolution is passed, or an order is made, for or in connection with the winding up of the other party (being a company) other than for the sole purpose of a scheme for a solvent amalgamation of the other party with one or more other companies or the solvent reconstruction of that other party;

14.3 Without limiting its other rights or remedies, MV Expo may terminate the Contract with immediate effect by giving written notice to the Client if the Client fails to pay any amount due under this Contract on the due date for payment

14.4 Without limiting its other rights or remedies, MV Expo may suspend the supply of Services or all further deliveries of Goods or Hired Goods under the Contract or any other contract between the Client and MV Expo if the Client fails to pay any amount due under this Contract on the due date for payment, the Client becomes subject to any of the events listed in clause 14.2(b) to clause 14.2(m), or MV Expo reasonably believes that the Client is about to become subject to any of them. 14.5 On termination of the Contract for any reason:

15.3 If the Force Majeure Event prevents MV Expo from providing any of the Services and/or Goods or Hired Goods for more than 2 weeks, MV Expo shall, without limiting its other rights or remedies, have the right to terminate this Contract immediately by giving written notice to the Client

### 16. General

(b) A notice or other communication shall be deemed to have been received: if delivered personally, when left at the address referred to in clause 16.2(a); if sent by pre-paid first class post or other next working day delivery service, at 9.00 am on the second Business Day after posting; if delivered by commercial courier, on the date and at the time that the courier's delivery receipt is signed; or, if sent by fax or email, one Business Day after transmission

(c) The provisions of this clause shall not apply to the service of any proceedings or other documents in any legal action

#### 16.3 Severance

(a) If any provision or part-provision of the Contract is or becomes invalid, illegal or unenforceable, it shall be deemed modified to the minimum extent necessary to make it valid, legal and enforceable. If such modification is not possible, the relevant provision or part-provision shall be deemed deleted. Any modification to or deletion of a

provision or

part-provision under this clause shall not affect the validity and enforceability of the rest of the Contract

(b) If one party gives notice to the other of the possibility that any provision or part provision of this Contract is invalid, illegal or unenforceable, the parties shall negotiate in good faith to amend such provision so that, as amended, it is legal, valid and enforceable, and, to the greatest extent possible, achieves the intended commercial result of the original provision
