4) Rene's Professional Pet Sitting, LLC is authorized to perform care and services as outlined in this contract. Rene's Professional Pet Sitting, LLC is also authorized by signature below to seek emergency veterinary care with release from all liabilities related to transportation, treatment, and expense. Should specified veterinarian be unavailable, Rene's Professional Pet Sitting, LLC is authorized to approve medical and/or emergency treatment (excluding euthanasia) as recommended by a veterinarian. Client agrees to reimburse Pet Sitter/ Rene's Professional Pet Sitting, LLC for expense incurred, plus any additional fees for attending to this need or any expenses incurred for any other home/food/supplies needed.

5) In the event of inclement weather or natural disaster, Rene's Professional Pet Sitting, LLC is entrusted to use their best judgment in caring for pet(s) and home. Pet Sitter/Rene's Professional Pet Sitting, LLC will be held harmless for consequences related to such decisions.

In consideration of these services and as an express condition thereof, the Client expressly waives and relinquishes any and all claims against said Pet Sitter/Rene's Professional Pet Sitting, LLC except those arising from negligence or willful misconduct on the part of the Pet Sitter/Rene's Professional Pet Sitting, LLC

**7)** Client understands that contract also serves as an invoice and takes full responsibility for PROMPT payment of fees upon start of services contracted. A finance charge of 2% per month will be added to unpaid balances after services after thirty (30) days. A handling fee (\$30) will be charged on all return checks. In the event it is necessary to initiate collection proceedings on the account, Client will be responsible for all attorney's fees and costs of collection.

**8)** In the event of personal emergency or illness of Pet Sitter, Client authorizes Pet Sitter to arrange for another qualified person to fulfill responsibilities as set forth in this contract. Client will be notified in such a case.

**9)** In the event that Rene's Professional Pet Sitting, LLC is required to employ a locksmith to gain entry into Client's premises due to a malfunction of the lock or a failure of the Client to leave a key, it shall be the responsibility of the Client to reimburse for all costs incurred. The Client expressly gives Rene's Professional Pet Sitting, LLC the authority to employ a locksmith on Client's behalf in the event of the aforementioned occurrences.

**10))** All pets are to be currently vaccinated for Rabies and provide proof to Rene's Professional Pet Sitting, LLC. Should Pet Sitter be bitten or otherwise exposed to any disease or ailment received from Client's animal which has not been properly or currently vaccinated, it will be the Client's responsibility to pay all costs and damages incurred by the victim.

**11)** The utmost care will be given in watching both your pet(s) and your home. However, due to extreme unpredictability of animals, we cannot accept responsibility for any mishaps of any extraordinary or unusual nature (example: biting, furniture damage, accidental death, etc.) or any complications in administering medications to the animal. Nor can we be held liable for injury, disappearance, death, or fines of pet(s) with access to the outdoors.
