If the required quorum is not present, another meeting may be called in **ten minutes time** and shall be deemed established with the attendance of at least two members of the Board of Directors and the presence of at least twenty-six percent (26%) of the Associates. On Third call, **ten minutes** after the second, the meeting shall be deemed established with the attendance of at least one member of the Board and the Associates that are present.
