This document is to be signed by the participant in order to participate in any Stables/activities that occur on the Calgary Shrine Stables (collectively referred to as the "STABLES")

I, (print name) _____ (the "Participant") and 18 years of age or older, and I am aware the **Stables** involves inherent risks, danger and hazards, involving all manner of injury or loss, including potentially serious of life-threatening injury and death, including but not limited to:

- a) The use of equipment, materials or facilities related to the **Stables**;
- b) The actions or negligence of myself or other participants in the **Stables**;
- c) The actions or negligence of **Calgary Shrine Stables** or its directors, officers, employees, volunteers, agents, invitees, or representatives of any kind (collectively referred to as the "**Organization**");
- d) The actions or negligence of the **Calgary Shrine Stables** or its councillors, officers, employees, agents or representatives of any kind: and
- e) Additional risk arising out of the **Stables** and related Stables and activities.

I, the undersigned **Participant**, hereby agree as follows:

- a) **To Waive Any And All Claims** of every nature and kind at law or equity or under any stature that I have or may have in the future against the **Organization**.
- b) **To Release The Organization** from any and all liability for injury, death, property damage, property loss or any other loss or expense that I may suffer or that my next of kin or legal representatives may suffer as a result of participation in or use of **Stables**, due to any cause whatsoever, including negligence on the part of the **Organization**;
- c) **To Hold Harmless And Indemnify The Organization** from any and all liability for injury, death, property damage, property loss or any other loss or expense to any party, including myself, as a result of participation in or use of the **Stables**, or other financial loss or expense including, without restriction, legal expenses and costs on a solicitor-and-his-own-client full indemnity basis in defending against such claims or enforcing the terms contained within this document; and
- d) **That This Agreement Will Be Effective And Binding** Upon myself, and my heirs, next of kin, executors, administrators and assigns.
- e) Calgary Shrine Stables is the operator of the facility owned by the Al Alzar Mounted Patrol a unit of Al Alzar Shrine Society
