Puppy Policy

We at Bold and Beautiful Bulldogs , guarantee that to our knowledge The puppy is healthy on the day of purchase. First shot and deworming Has been done the purchaser agrees to take puppy to a licensed veterinarian of choice within three days . If the Vet determines the puppy To be unfit for purchase due to a congenital disorder, the puppy may Upon presentation of a written diagnosis from said Veterinarian be returned for a refund . If you have any issues with your bulldog puppy You are encouraged to contact us for advice and a plan how to treat And care for your puppy.

We offer a replacement guarantee on our puppies up to 12 months of age . If the puppy develops congenital or hereditary life threatening disorders we will replace the puppy with another puppy of equal value at our next opportunity provided the conditions below are met.

1. Buyer will offer this puppy back to breeder first , if ever for sale .
2. If puppy dies with in the 12 months replacement will be given if there is a Veterinarians Autopsy report which indicated the cause of death was congenital . Buyer pays all expenses for Autopsy and shipping fees to get the replacement puppy .
3. Buyer agrees to provide routine Veterinary care of this puppy . This includes proper vaccinations, routine check ups , heartworm treatments, and records indicating such care should buyer have to return a puppy for replacement .
4. Buyer understands contract will be void if buyer fails to provide routine Veterinary care if puppy is transferred or injured by accident or neglect. This guarantee does not cover any common puppy ailments worms, vitamin deficiencies, any viral or bacterial infections or disorders brought on by parasites. Guarantee does not cover

common breed related problems such as cherry eye , “loose” hips, skin allergies or demodectic mange.

5. We will not be responsible for any Veterinarian fees or cost owed by the buyer. Buyer is aware that owning a bulldog puppy means regular trips to the veterinarian and understands that he/she will be responsible for those payments.
6. There is no guarantee or promise of fertility or success in the show ring.
7. We are not responsible for temperment issues as they can be caused by lack of training ,discipline, and dog socialization.
8. This contract is valid only for the original buyer and puppy and it is not transferable .
9. Buyer understands and agrees that bulldogs are inside dogs and require air conditioned living conditions to prevent overheating
10. Buyers who buy for pet only must neutered or spayed by 6 month of age for guarantee to be valid .
