

## Stud Dog Contract

This agreement, dated as of \_\_\_\_\_, 2024\_, is between \_\_\_\_\_ the Bitch Owner(s), and \_\_\_\_\_, the Stud Owner . The subject of this Agreement is the for the breeding of the dog(s) listed below.

1. **Compensation.** Bitch Owner agrees to pay Owner a [non-refundable] Stud fee of \$ 500 for the transportation of the Stud. Payment of Stud service fee will be made prior to the handing over of the stud. All payments due under this Agreement shall be made in US Dollars via payments through Zelle, Cashapp, or PayPal.

2. **Stud Fee Puppies.** Stud Owner has a right to 2 pupp(y)(ies), which will be selected by [Stud Owner] and will be the 2nd and 9th pick(s), varying by litter size. If a female does not produce more than 8 puppies, Stud Owner will receive only [1] pupp(y)(ies). The Stud fee pupp(y)(ies) must be selected within [2 weeks]] of the puppies being born. Stud pupp(y)(ies) will have dewclaws removed, tail docked, vaccines and dewormings prior to pickup and will be the responsibility of [Bitch Owner] to ensure all have been completed as per breed standard. [and the Stud Owner's kennel name must appear first on any registration paperwork for such Stud Fee pupp(y)(ies)]. Bitch Owner agrees to send video, pictures, and updates on all Stud Fee pupp(y)(ies) as requested by Owner.

### 3. Breeding & Litter

a. **Breeding.** This breeding will be a natural breeding. The Bitch's first litter will be sired by Stud Dog aforementioned above. Bitch Owner and Stud Owner agree to allow [two] separate tyings between Bitch and Stud. Time and Date of Breeding(s) will be agreed upon by Stud Owner and

Bitch owner.. Both Bitch Owner and Stud Owner agree to be present with both Bitch and Stud on agreed upon Times and Dates.

b. **Repeat Breedings.** Stud Owner [does not guarantee any puppies will result from the Breeding; provided that if no puppies result from the Breeding,] [Stud Owner] agrees to provide [one] repeat breeding(s) to the same Bitch on the Bitch's next consecutive heat cycles should pregnancy not occur on other attempts.

c. **Breeding Expenses.** Bitch Owner agrees to pay all expenses incurred for the Breeding at the time in which they are incurred, including, but not limited to, transportation of the Stud, all veterinary costs, artificial insemination costs, semen collection (fresh, chilled, or frozen), and shipping of the same, as applicable.

d. **Vaccinations and Exams.** Bitch Owner agrees to accept full responsibility to ensure that all offspring resulting from the Breeding(s) be treated for parasites, receive vaccinations, tails docked and dewclaws removed.

4. **Stud Owner and Bitch Owner Obligations.** Stud Owner and Bitch Owner represent, warrant and agree as follows:

a. **Bitch.** The Bitch is healthy, of sound and stable temperament, is of breeding quality, disease and parasite-free and will be groomed and bathed before she is shipped or brought to be bred (if applicable). The Bitch has not recently been exposed to any stud dog prior to the Breeding.

b. **Bitch Owner's Right of Refusal.** Bitch Owner has the right to return the Stud to Stud Owner or refuse to breed the Stud Dog to the Bitch, if Bitch Owner determines (in their reasonable discretion) that the Stud is not in the proper physical condition upon arrival. In such a case, Bitch Owner agrees to accept financial responsibility for all reasonable costs incurred in the return of the Stud.

c. **Notification.** Stud Owner, will be notified in writing (by email or text), of the birth and number of puppies within [24hrs] of the Breeding. If Bitch Owner does not hear from Stud Owner (by email or text) within [48hrs] of birth notification, Bitch Owner reserves the right to keep Stud pupp(y)(ies) fee/pick of the litter.

d. **Accidental Breedings.** To keep the Bitch properly confined following the Breeding for the duration of her heat cycle to ensure there are no accidental breedings. If such accidental breeding does occur, Bitch Owner agrees to notify Stud Owner within 24 hours. In addition, Bitch Owner agrees to place half of the litter with Stud Owner should the accidental breeding take hold. Bitch Owner agrees to breed Bitch on her next year cycle herein after the birth of accidental litter to Owners Stud Dog to honor previous agreement.

e. **No Stud Dog Owner Liability for Disease or Injury.** Stud Owner shall have no responsibility for any disease contracted by the Bitch or injury resulting to the Bitch that is not a direct result of the Breeding.

5. **Stud Owner and Bitch Owner Obligations Cont.** Owner and Bitch Owner represent, warrant, and agree as follows:

a. **Stud Dog.** Stud Owner agrees that the Stud Dog is healthy, of sound and stable temperament, is of breeding quality, is parasite and disease-free and, if a natural breeding, will be groomed and bathed before the Breeding.

b. **Bitch Care.** The owner of the stud dog shall exercise due caution in handling and care of the bitch, but is not liable for any injuries, illnesses, or loss of the bitch.

c. **Litter Registration.** Litter Registration will be handled by the Bitch Owner and signed by the Stud Owner. Bitch and Stud Dogs' Names and Registration Numbers will be listed on puppy(y)ies registration. Stud Fee puppy(y)ies will be registered with Stud Owners Kennel Name [King's Kourt ] on any following paperwork.

d. **No Bitch Owner Liability for Disease or Injury.** Bitch Owner shall have no responsibility for any disease contracted by the Stud Dog or injury resulting to the Stud Dog that is not a direct result of the Breeding.

6. **Placement of Puppies**

a. **Bitch Owner Obligations.** Bitch Owner agrees not to transfer ownership, in any way, of any puppy resulting from the Breeding to any person or organization whose intent is to resell, trade, or give away the puppy or to use it in any laboratory experiments (including, but not limited to, pet shops and pet shop owners, and research laboratories.

b. **Stud Owner Obligations.** Owner agrees to help with the placement of the puppies including but not limited to, advertising, referrals, ads, etc... if the Bitch Owner requests assistance. If the Bitch Owner requests assistance, Stud Owner is entitled to ½ of the profits for each puppy the Stud Owner places. Bitch Owner is not obligated nor required to ask for assistance.

7. **Confidentiality of Disputes.** Stud Owner and Bitch Owner agree, that in the event of a dispute between them, neither will publish or communicate the existence or content of such dispute in any media or forum, including social media, provided that this provision shall not prevent either party from bringing legal action or engaging in confidential mediation.

8. **Agreement to Mediate.** If a dispute arises out of or relates to this Agreement, or the alleged breach thereof, and if the dispute is not settled through negotiation, the parties agree first to try in good faith to settle the dispute by mediation before resorting to arbitration, litigation, or some other dispute resolution procedure. The process shall be confidential based on terms acceptable to the mediator and/or mediation service provider.

9. **Governing Law.** This Agreement, and all matters arising out of or relating to this Agreement, shall be governed by and construed in accordance with the laws of the State of \_\_\_Georgia\_\_\_ without regard to the conflicts of laws provisions thereof.

10. **Miscellaneous.** This Agreement constitutes the entire agreement between the parties regarding the subject matter herein and supersedes all prior or contemporaneous agreements, negotiations, discussions and understandings, written or oral, between the parties with respect to such subject matter. Neither party may assign, transfer, or subcontract any obligations (or rights) under this Agreement without the prior written consent of the other party. No changes, modifications or waivers to this Agreement will be effective unless in writing and signed by both parties. In the event that any provision of this Agreement is determined to be illegal or

unenforceable, that provision will be limited or eliminated to the minimum extent necessary so that this Agreement shall otherwise remain in full force and effect and enforceable. This Agreement may be executed in any number of counterparts and such counterparts together shall constitute the same instrument. This Agreement may be executed by electronic signature, which shall be considered as an original signature for all purposes and shall have the same force and effect as an original signature.
