



Remote Therapeutic Monitoring and Chronic Care Management for Pain Management

Our Goal: Improved patient outcomes while generating revenue

Evolving technology is altering the way healthcare is delivered, and remote patient monitoring (RPM) is leading to a transformation in primary care, specialty care along with many different care settings. With the increased need and demand for virtual care, now pain management providers are well-positioned to reap the benefits associated with remote therapeutic monitoring (RTM) services & technology, coupled with chronic care management (CCM) or principal care management (PCM). RTM has significant patient applications for pain management that may lead to further complications.

MedHab's RTM and CCM Solution

MedHab offers a unique RTM pill dispensing device that can be programmed to tone and remind patients when to take their medications. Additionally, the pill dispenser can be locked, and time stamps each time the dispenser is opened. Within the pill dispenser is a secondary device with a push button mechanism so that the patient provides immediate feedback regarding their pain level (mild, moderate, severe) The device transmits the data to our remote staff for monitoring. As necessary, MedHab's remote staff works directly with the provider's staff should additional services, by the provider, are necessary.

MedHab also includes the MyHeart+ line of devices such as a pulse oximeter or blood pressure cuff as needed. All MedHab devices offer an RTM or RPM solution, coupled with CCM that affords pain management providers with a turn-key outsourced platform through routine discussions with the patient and with nursing staff and providers as needed. All data collected is securely transferred to a HIPAA secured server where our outsourced auxiliary support team manages device monitoring, patient contact, patient follow up, and associated CCM when applicable. When escalation is necessary, the support team will contact your staff pursuant your specific protocol.

Either your biller or MedHab can bill the services through your NPI for the appropriate reimbursements. All patient services work is done through proprietary software that meets Medicare's regulations.

What we offer: A simple, low effort mechanism for providers to improve the health care and health status of patients utilizing a team approach for patient care with minimal staff time investment.
