THIS STRATEGIC INVESTMENT ENCOMPASSED A WIDE ARRAY OF INITIATIVES, INCLUDING THE ACQUISITION OF ADVANCED EQUIPMENT AND TECHNOLOGY, THE DEVELOPMENT AND SUPPORT OF YOUTH ENGAGEMENT PROGRAMS, SPECIALIZED TRAINING FOR OFFICERS, AND CRITICAL INCIDENT SUPPORT, THEREBY REINFORCING THE PPD'S OPERATIONAL EFFICIENCY AND COMMUNITY ENGAGEMENT EFFORTS. KEY HIGHLIGHTS OF THE GRANT APPROVALS INCLUDE A SUBSTANTIAL ALLOCATION OF FUNDS TOWARDS YOUTH ENGAGEMENT, WITH \$40,000 DEDICATED TO PROGRAMMING DESIGNED TO FOSTER POSITIVE INTERACTIONS BETWEEN LAW ENFORCEMENT AND YOUNG COMMUNITY MEMBERS. THE 3RD ANNUAL HONOR RUN/WALK AND THE 6TH ANNUAL WOMEN IN BLUE EVENT RESPECTIVELY PAID TRIBUTE TO FALLEN OFFICERS AND CELEBRATED THE ACHIEVEMENTS OF FEMALE OFFICERS WITHIN THE PPD.
