THE FOUNDATION ALSO PROVIDED OVER \$390,000 IN FINANCIAL ASSISTANCE TO OFFICERS AND THEIR FAMILIES DURING TIMES OF CRISIS. ADDITIONALLY, WE RECEIVED IN-KIND GOODS DONATIONS TOTALING \$111,435.
