### 6. DELIVERY WINDOW

- Please allow at least 10-14 business days from the time of your order for shipment of items.
- Please note, because our business is a true Artisan business that works on Mother Nature's schedule and sources supplies from other Artisans, who bring a skill level to their trade that can't be found elsewhere, there may be times we can un-expectantly be impacted by seasonal growth, harvest and/or other cultural down time.
- We try to be conscious of these occurrences and alert those that are in "the need to know status" ASAP.
   We ask for your patience during these times.

### 7. SHIPPING

- We ship Monday-Friday.
- We provide free USPS or UPS shipping for all orders \$200 and over, and within the continental USA.
- Please remember possible shipping delays that are out of our control may occur, especially during peak holiday seasons. Normal expected delivery time frame is 3-5 business days from the time the order is shipped.
- A tracking number will be emailed within 24 hours from the time the order is shipped.
- We cover the cost of postal insurance on shipments we ship with USPS or UPS.

#### 8. RETURNS
