

**ROAD USE PERMIT
FOR
THE WILDERNESS**

THE Wilderness Property Owners Association, Inc, hereinafter called the "POA" hereby issues this Road Use Permit, hereinafter called "permit" to _____, hereinafter called "Owner" for the purpose of transporting excessive length and/or overweight loads(s) over the roads of The Wilderness for the purpose of performing approved construction on lot/phase# _____ of The Wilderness.

THIS PERMIT IS ISSUED TO THE OWNER AND IS SUBJECT TO STRICT COMPLIANCE

BY THE PERSON UTILIZING THE PERMIT WITH THE FOLLOWING TERMS AND CONDITIONS.

1. The towing vehicle, trailer, and load must meet the description and weight as stated in Owners permit application which is attached to this Permit.
2. Neither the towing vehicle or trailer may drive on road edges or road shoulders and may get off the paved portion of the roadway only on approved driveways or construction crossings.
3. No tracked vehicle or other equipment may operate on a paved roadway or road shoulder unless sufficient material is placed under the tracts to insure that no damage will occur.
4. No permitted load may be moved over roads during prohibited times as stated in the Declarations or the Additional Rules of The Wilderness.
5. No permit may be exercised until all required fees of \$_____ have been paid to and received by The Wilderness.
6. The Owner or his designee is hereby authorized to use the roads of The Wilderness to transport the load by the method as described in the permit application by the following route

on the following dates and times _____

7. Prior to entering The Wilderness the Owner or his designee must contact one of the persons on the included contact list. The effort to contact these individuals should begin by attempting to contact the first name on the list and working down the list in order.

The required impact and permit fees allow the right to use the roads of The Wilderness within the limits of these regulations and the terms of the permit. The mere use of the roads will cause damage and wear which will necessitate eventual repair even though the damage is not visible. Regardless of the payment of fees or the issuance of any road use permit the Owner(s) are liable for the actual costs of repair for **any** visible damage to the road or other common property structures caused by the use of the roads by the Owner, his agent, servant, contractor, tenant, or invitee.
