INITIAL INFORMATION:

On 02/03/2022, at approximately 8:27 a.m., I was in phone contact with Detective Sgt. Sherri Casper as it pertained to a critical incident or officer involved shooting in the city of Madison. At the time of this contact, I was off and was at my residence and ultimately responded into work to assist in the investigation.

I ultimately arrived on scene at approximately 9:45 a.m., approximately 90 minutes after the shooting was believed to have taken place. Shortly after my arrival, I had contact with DCI Special Agent Scott Leck for the purposes of learning the occupants of a number of vehicles that were involved in the incident.

INITIAL OBSERVATIONS:

Upon arriving on scene, I observed a vehicle that I knew to belong to State Trooper Lorbecki that was facing in an easterly direction in the westbound turn lane from East Park Boulevard. In front of Lorbecki's vehicle was a number of vehicles that were later determined to be directly involved in the incident, which were assigned to various taskforce members from primarily DCI. I noted that the amount of vehicles stopped in this turn lane that were involved were presently unoccupied and numbered seven vehicles total, one of which being the suspect vehicle belonging to that of Quadren Wilson.

In speaking with Special Agent Leck, he advised that he just simply wanted to tell me the identities of the individuals that were occupying the aforementioned vehicles and for the purposes of this report these vehicles will be numbered beginning with number one, working from west to east.

VEHICLE 1:

This vehicle is a dark colored SUV which was Trooper Lorbecki's Wisconsin State Patrol vehicle. I was advised that this vehicle was solely occupied Trooper Lorbecki. Vehicle 1 or the Lorbecki vehicle arrived on scene after the reported shooting which was later confirmed upon review of squad video footage from within Lorbecki's squad.

VEHICLE 2:

Vehicle two is a gray Ford F150 pickup truck that was operated by Special Agent Leck and occupied by DEA Special Agent Anthony Charmota at the time of this incident. The license plate/registration on Agent Leck's vehicle was noted as This rear of the is vehicle was touching vehicle 3 identified being PZ 3590. below, specifically the rear bumper area of Agent Leck's vehicle was in contact with the front bumper area of the Wilson vehicle.

Agent Leck did advise that himself and Special Agent Charmota were the only two occupants of his F150 at the time of this incident. Video surveillance footage

obtained from Trooper Lorbecki's squad later confirmed this information.

VEHICLE 3:

Vehicle three is a 2016 Hyundai Tucson, gray in color, which was known to be occupied and operated by Quadren Wilson at the time of this shooting. This vehicle was displaying WI registration 328-ZWE.

VEHICLE 4:

Vehicle four is a Dodge Ram pickup that was stopped immediately behind the involved Hyundai Tucson. The front bumper area of this vehicle was in contact with the rear bumper area of the Hyundai Tucson. This vehicle was bearing WI registration plate HE 2532. Agent Leck reported that this vehicle was operated by a Jeff Hale and other occupants of the vehicle included a Mark Wagner, Nate Peskie and a Brian Hawley.

VEHICLE 5:

Vehicle five is a green in color Ford F150 pickup which was stopped immediately behind the aforementioned Hale vehicle (4) but was not in physical contact with any vehicle as those mentioned previously in this report. This vehicle was being WI registration KN 4816. Agent Leck reported this vehicle was operated by a Jeff Berkley and occupied by a Jay Jurci a party named King and a James Pertzborn.

VEHICLE 6:

Vehicle six is a black in color Ford F150 pickup which according to Agent Leck was operated by a Kyle Dilley and occupied by Frank Garritano, Jay Novak and a Michael Mansavage. I noted the registration being displayed on vehicle as being Illinois E31 2982.

VEHICLE 7:

Vehicle 7 in the sequence was known to be the vehicle assigned to FBI Taskforce officer and MAPD Detective Susan Gonzalez. Any occupants of Gonzalez's vehicle were not definitively known by Leck at that point in time and he could only identify the occupants of those that were part of the arrest and/or contact team, which included in this sequence vehicles two, four, five and six. It was determined that that vehicle 7 was not part of the arrest attempt and arrived in the vehicle sequence a period of time afterwards.

ADDITIONAL INFORMATION AGENT LECK:

During my conversation with Leck as it pertained to the occupants of the aforementioned vehicles, he also shared with me that during the course of this apprehension of Quadren Wilson that taskforce members had located Wilson and were in the process of surveilling him in an attempt to complete an apprehension and had recently departed a local Park and Ride location and were following Wilson out of the area. Once arriving at the present vehicle location, near the traffic signal or lights at westbound East Park Boulevard, the decision was made that they would essentially box in or bumper lock the Wilson vehicle to attempt

the apprehension.

As part of this process, Leck advised that he placed his vehicle into reverse, once Wilson was stopped behind him and allowed momentum back him up the Wilson Hyundai Tucson. While doing so, Leck believed that Wilson had begun honking his horn before Leck made contact with the Wilson vehicle.

Leck advised that as this was happening, he observed a significant amount of smoke coming from what he believed was the tires of the Wilson vehicle that was leading him to believe that Wilson was trying to essentially push his truck out of the way to avoid apprehension. Leck went on to state that although Wilson was attempting to do this, he was unsuccessful in moving Leck's vehicle any significant distance.

Leck was aware that the taskforce vehicle behind Wilson at that point, which again was operated by Hale, was going to be essentially bumper locking Wilson's vehicle from behind, at which time the arrest team would approach.

Leck advised that as this was transpiring, he had moved himself from the typical seating position in his truck and attempted to lower himself, essentially beneath the dashboard or near the floorboards of his vehicle and advised Agent Charmota had been doing the same from his seated position, which was in the front passenger seat.

Leck advised that while he was in the process of doing so, he was able to see that the smoke coming from Wilson's vehicle was significant and continuing and was followed very shortly thereafter by a sequence of gunfire which Leck believed was between 5 and 10 shots. Leck also advised that from his position, he was able to look out of the vehicle through the passenger side mirror and stated that he had observed what was believed to be the front passenger side window get blown out from the inside.

Leck advised it was apparent that there was shooting at that point in time which was announced via radio transmissions and he essentially stayed in his position in the car for a number of minutes before he and Charmota eventually exited his vehicle at approximately the same time.

This information was later confirmed upon a review of squad camera footage from Trooper Lorbecki's car, which does show Leck and Charmota exit their vehicle approximately three minutes after the shooting has taken place from within the F150 that was stopped in front of the Wilson vehicle. Leck advised that after he exited the vehicle, he responded to the immediate area where the shooting had occurred and had received information that the arrest team may have been fired upon by Wilson and the round had possibly impacted a shield.

Leck advised that once he was out of his vehicle, he noted that the additional taskforce members present that he had previously identified were in the process of securing Wilson and rendering aid.

In conclusion, Leck advised that the rifle that was reportedly involved in this incident was placed into the rear cargo bed of Agent Dilley's vehicle, identified previously in this report, and was locked. I was advised by Agent Leck that the shield that was involved in the incident as well as a Haligan tool that was used to break windows was also placed in this same cargo storage area in Agent Dilley's vehicle. This was confirmed during a later review of Trooper Lorecki's squad cameras foot age which does show the involved shield in this incident.

This information from Leck as it pertained to the location of an involved firearm, shield and Haligan tool was shared with DCSO CSU Deputy James Plenty. Plenty ultimately located these items during the course of this investigation and took possession of these items.

I did subsequently observe the shield itself along with CSU Deputy Plenty and did note that the shield did have various areas of damage to it, however, it was not definitively known when this damage may have occurred during this incident or another.

One can refer to photographs of this shield completed by CSU Deputy Plenty for further information.

The areas of damage on the shield could possibly have been from projectile contact, however, this was not definitively known at that point in time.

RELEASE OF PROPERTY:

At approximately 10:45 a.m., I had second contact with Agent Leck as he had requested to remove a laptop from his vehicle as well as an envelope containing some US Currency from an unrelated investigation. These two particular items did not appear to have any evidentiary value or connection to this particular incident, so the items were allowed to be removed from the vehicle.

The items removed consisted of one laptop computer in a case as well as one manila envelope with US Currency inside. Prior to these items being released, they were photographed by CSU Deputy Plenty and were turned over to Agent Leck's custody, which concluded my contact with Agent Leck on this date.

I am aware that Agent Leck was interviewed further with greater detail in the days following the shooting.

This case remains under investigation.
