SEARCH WARRANT COMPLETION

On 02/03/2022, I obtained a search warrant specifically targeting a 2016 Hyundai Tucson that was silver in color, presently bearing Wisconsin registration 328ZWE. This vehicle was known to be occupied by Quadren Wilson during the morning hours of 02/03/2022 at the time of an officer involved shooting.

As part of the subsequent investigation, the search warrant was obtained to search said vehicle and upon completion was reviewed and approved by Dane County Circuit Court Judge Valeria Bailey-Rihn.

Upon review, Judge Bailey-Rihn signed the warrant and turned it over to my custody with my endorsement at 4:40 p.m. on 02/03/2022.

Beginning at approximately 5:00 p.m., myself and DCSO Detective Chris Grunewald performed a cursory search of the involved vehicle subject to this search warrant, looking for any items that were potentially hazardous or dangerous i.e. a firearm or other item that could pose a potential hazard during transport. The vehicle was going to be towed from the scene to the Dane County Public Safety Building pending a more thorough examination and processing and additional search in better lighting. In performing this cursory search, Detective Grunewald and I did not locate any items that were hazardous at that point in time and nothing was removed from the vehicle.

I did open a purse/bag that was positioned on the front passenger side seat in an attempt to determine if the backpack contain a firearm. The bag/purse was full of various items but did not contain a firearm. I did note that the bag/purse contained amongst other things a large sum of US Currency and other personal items which were covering other items in the bag. I left the currency in the bag/purse pending a more thorough search at a later time in more desirable conditions. The contents of the bag were not removed but rather just moved slightly to confirm no firearm to be present.

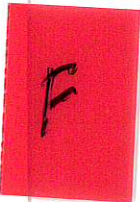
Ultimately, this vehicle was towed to the Public Safety Building during the late evening hours of 02/03/2022 pending a more complete search and processing by DCSO CSU personnel. The search warrant on the vehicle continued on 2/4/21. The totality of the items found or seized in the execution will be noted on the search warrant return document. I did provide DCSO Det. Jason Walters with a copy the of warrant to place within the Hyundai Tucson following the search.

A copy of the warrant was attached to the law record for this case pending further need.
