Law Supplemental Narrative

were responding to the intersection of American Parkway and Eastpark Boulevard after or during the time they heard, "Go, go, go" via radio indicating a takedown was about to occur. SA Mansavage said they were coming from the Kwik Trip area which is located approximately a block north of the intersection of American Parkway and Eastpark Boulevard.

As SA Mansavage approached the scene, he could see a cloud of smoke coming from the area of the takedown and he remembered hearing "tires squealing."

SA Mansavage also reported seeing SA Mark Wagner (ph) holding a shield with his handgun out and he was on the driver's side area of the silver vehicle driven by Quadren Wilson at the time. He said he saw SA Wagner backing up from Quadren Wilson's vehicle and falling backwards over the curb in the roadway which separates eastbound from westbound Eastpark Boulevard traffic. SA Mansavage also reported seeing SA Pesky (ph) pointing his rifle toward Quadren Wilson's silver vehicle. SA Mansavage said he also could hear shots and he indicated it appeared the shots were going through the window of Quadren Wilson's silver vehicle. SA Mansavage said they parked their vehicle and he got out with his gun out, but after the shots stopped, everything was quiet for a period of time so he holstered his gun and then approached SA Pesky, tapped him on the shoulder indicating that he was present and SA Pesky was standing with his rifle pointed towards Quadren Wilson's silver car near the rear driver's side area.

SA Mansavage said he saw rifle casings on the pavement between the curb and Quadren Wilson's vehicle and he also saw handgun ammunition beyond the curb and on the ground which was the roadway for eastbound traffic on Eastpark Boulevard. The casings were in an area located on the driver's side area of Quadren Wilson's vehicle.

SA Mansavage indicated that after the shots were fired, he approached the driver's side door of Quadren Wilson's vehicle and saw Quadren Wilson with his hands over his head and lying across the console and into the passenger seat area. SA Mansavage stated he needed to break out the driver's side window of Quadren's vehicle in order to better see Quadren in the vehicle. He said he smashed out the window and believes that's when he cut his right hand. SA Mansavage said he saw Wilson's hands over his head and during this process, he initially had his T.A.S.E.R. pointed through the window at Quadren, but then holstered the T.A.S.E.R. SA Mansavage said he opened the driver's side door and J. Novak was on the passenger side of the vehicle. SA Mansavage said he grabbed Wilson's hands and SA Novak put handcuffs on Wilson. SA Mansavage indicated that he put his T.A.S.E.R. away at that point. SA Mansavage indicated they evaluated Wilson's injuries and Frank Garritano, the TEMS guy responded and assisted with evaluating Wilson's injuries. Initially, SA Mansavage said they were going to pull Quadren out of the vehicle, but he said "his back" and they stopped because they didn't want to cause further injury to Wilson. SA Mansavage said he saw Frank cut Wilson's clothing off in order to evaluate his injuries. SA Mansavage said he went to the back seat of the vehicle with SA Brian Hawley during the evaluation of Quadren's injuries. After his clothing was cut off, SA Mansavage said he saw two entries into his lower back and they were not bleeding at that time. He said SA Hawley had a chest seal and gave it to Garritano. Also, a blanket was brought to the vehicle in order to keep Wilson warm and the heat in the vehicle was turned up.

SA Mansavage said Madison Fire took over treatment. SA Mansavage said Wilson had become less responsive during the evaluation of his injuries. SA Mansavage indicated that after Madison Fire showed up, he had no further involvement with Wilson.
