WSP Trooper Lorbecki Video:

On 2/4/2021, I performed an initial viewing of squad video that recorded part of an officer involved shooting near the intersection of American Parkway and Eastpark Blvd in Madison, WI.

The length of this recording is 13 minutes and 34 seconds.

During the review, I made a number of observations of interest. Beginning at approximately 20 seconds into the recording, Trooper Lorbecki is approaching the scene from the west on Eastpark Blvd. On this approach, white smoke can be seen coming from the area of the Hyundai Tucson. One can also see party believed to be S/A Wagner fall to the pavement on the opposite side of a median south of the stop location.

As the approach continues, the smoke from the area is gone and one can see S/A Wagner on one knee and then coming to his feet while other task force members are in the vicinity of the Hyundai Tucson. Over the next several minutes, task force members and local law enforcement are seen arriving in the area and seemingly contacting and rendering aid. These observations are largely obstructed by a gray F150 truck that is positioned in front of the Hyundai Tucson.

Approximately 42 seconds into the recording, DCI Volenburg is seen arriving in the area and parking his vehicle blocking westbound traffic. Approximately 1 minute and 42 seconds into the recording, one can see DEA S/A Jackie Montgato arrive and also block westbound traffic. This confirmed that both arrived well after the shooting. The video also confirmed the presence of those known to be directly involved or present at the time of the shooting as being in the area, contacting Wilson and rendering aid to Wilson. The identities of those present is documented in a separate supplemental report.

Approximately 2 minutes into the recording, Madison Police members are seen arriving on scene.

Approximately, 3 minutes and 20 seconds into the recording, DCI S/A Leck and DEA S/A Charmota are seen exiting the F150 parked in front of the Hyundia Tucson confirming their initial statements and also confirming neither were outside the vehicle at the time the shooting began.

Approximately 5 minutes and 30 seconds into the recording, DCSO patrol Deputies are seen arriving on scene.

Approximately 7 minutes and 20 seconds into the recording, Madison Fire is observed arriving on scene.

Approximately 10 minutes and 55 seconds into the recording, Wilson is seen being removed from the Tucson and taken via stretcher off camera to a waiting ambulance approximately 12 minutes and 49 seconds into the recording.
