lethal. Warden King stated at no point did he remove his firearm from his holster.

While approaching the suspect vehicle, Warden King heard sounds of sirens which he believed were possibly coming from Special Agent Hale's vehicle. As Warden King began to get closer to the suspect vehicle, near the A-pillar of Special Agent Hale's vehicle, he was hearing engines revving. Warden King continued to approach hearing what he described as vehicles crunching as if the bumpers were being compressed. Warden King stated he did not hear any tires squealing at this time. While near the A-pillar, Warden King observed a contact/arrest team at the driver's side of the suspect vehicle. He observed Special Agent Mark Wagner at the driver's side window with Special Agent Nate Peskie and Special Agent Mike Mansavage all at the driver's side of the vehicle. Warden King stated while approaching the SIC maneuver he observed smoke coming from the vehicle. Warden King was unsure if it was coming from the exhaust or tires of a vehicle.

Warden King heard commands being given into the suspect vehicle such as "police" and "show me your hands." Warden King stated he was unable to see inside the vehicle due to the heavy tint inside of it.

At this point, Warden King stated he heard a series of gunshots. He estimated between 1 and 15 shots were fired, but was unsure who had shot initially. Warden King observed Special Agent Wagner falling backwards from the vehicle towards the median of East Park Boulevard onto his butt. Immediately upon seeing SA Wagner falling backwards and the gunfire, Warden King believed SA Wagner was potentially shot.

Warden King observed Special Agent Peskie focused on the front driver's side window. In front of the driver's side window, Warden King said he observed multiple bullet holes in the front driver's side window. Warden King was unsure how many bullet holes were in the window at that time.

At this point, Warden King observed Special Agent Mansavage break out the rear window with a Halligan tool, which they typically use for breaching.

Warden King was unsure who else was up at the vehicle at this time. Warden King indicated he had tunnel vision on the vehicle and was attempting to see the suspect inside.

At this point, Warden King went to the rear of Special Agent Hale's truck towards the passenger side. Once on the passenger side of Special Agent Hale's truck, he observed a second team approaching on the passenger side of Wilson's vehicle. Warden King observed they were going towards Wilson's vehicle. The team then appeared as if they were rendering First Aid to Wilson. Warden King remembers hearing Special Agents asking for chest seals and medical bags. Warden King heard the suspect begin to yell about his legs and was responding to officers at this point.

Warden King then returned back to the driver's side of the vehicle to assist his partners. Once on the driver's side of the vehicle, he observed that the driver's side window which had holes in it previously was no longer intact and was broke.

Warden King was unsure who had fired the weapon first and was unsure if the suspect had fired.
