radio that Wilson was on the move and he also heard SA Leck was able to get out in front of Wilson's vehicle at a red light on Eastpark Boulevard at American Parkway. SA Mansavage said he didn't know who the rear vehicle was at that time but suspected it was either SA Berkley or SA Hale. SA Mansavage said the arrest team in SA Dilley's vehicle responded by starting to move toward Eastpark Boulevard and American Parkway. I asked SA Mansavage to mark a dotted trail in order to mark the route they took to the incident location on Eastpark Blvd. He marked the route they took from Am Center Drive to Buttonwood Drive to American Parkway and then to the final location on Eastpark Boulevard. As they reached the Buttonwood Drive and American Parkway intersection, he heard via radio "go, go" but he does not know who called it out. SA Mansavage indicated that meant an arrest was going to occur.

SA Mansavage stated that as they traveled on American Parkway towards Eastpark Boulevard and passed Erin's Pub, he saw a "huge cloud of smoke" coming from Wilson's vehicle. As they traveled closer to the scene of the incident, he also saw tires spinning and there was heavy exhaust smoke coming from Wilson's vehicle.

SA Mansavage stated that as they turned onto Eastpark Boulevard from American Parkway, he saw the contact team on the driver's side of Wilson's vehicle. He later observed that the contact team consisted of SA Hawley, SA Wagner, and SA Peskie.

SA Mansavage stated that it was not a compliant vehicle containment (SIC maneuver) and Wilson wasn't putting the vehicle in park. SA Mansavage stated there was "tons of smoke" and as they turned from American Parkway onto East Park Boulevard, he heard a "pop" sound. He said it really got his attention and he was wondering if they deployed a flash bang. At the same time he saw SA Mark Wagner fall back over the median and into their lane of traffic. SA Mansavage said he saw SA Peskie shooting his rifle into the vehicle as Mark was falling backward onto the roadway and into their lane of traffic. At that time, SA Mansavage stated, "I'm thinking Mark is shot." SA Mansavage also said he remembered holes were "forming" in the window on the driver's side of the vehicle.

SA Mansavage stated that as SA Dilley drove from American Parkway onto Eastpark Boulevard, SA Dilley swerved the truck and believed they were in the line of fire. SA Mansavage indicated the following occurred at the same time; SA Dilley's truck was on the driver's side of Wilson's vehicle just after SA Wagner fell over the curb going backwards and then fell into their lane of traffic while SA Peskie is shooting into Wilson's vehicle. SA Mansavage indicated that he knew SA Peskie was shooting the rifle because he could see muzzle flash and smoke coming from the rifle that SA Peskie was holding. SA Mansavage was later asked if the first pop that he heard as they were traveling in the vehicle from American Parkway onto East Park Boulevard was a gunshot and he said that he was not sure at that time and that it could have been a flash bang because he didn't see any muzzle flash to go along with the pop sound. SA Mansavage also commented that there were holes forming on the driver's side window, but he didn't know if those holes were being made from inside the vehicle to the outside or from the outside of the vehicle to the inside of the vehicle.

SA Mansavage was later asked if he knew who fired a gun first and he said he didn't know.

SA Mansavage stated that SA Dilley drove his squad over the median on Eastpark Boulevard and then pulled in behind SA Berkley's squad and SA Berkley's squad
