SUMMARY:

At the request of Dane County District Attorney Ozanne he viewed the Hyundai Tucson (evidence TAG number 44632) at the Dane County Sheriff's Office vehicle evidence building on three separate occasions. To my knowledge consent from the vehicle owner has not been revoked.

MAY 18 2022:

On May 18th 2022 DA Ozanne and DA Investigator Pete Hanson met with Det. Hendrickson, Deputy Leatherberry and myself at the vehicle evidence building to view the vehicle. The vehicle was moved by Deputy Leatherberry with a bobcat and the inside was not accessed. Det. Hendrickson also took possession of the shield (TAG 44373) for this viewing.

JUNE 03 2022:

I was not present for this viewing. However, in a discussion with Det. Hendrickson he informed me that DA Ozanne wanted to see the inside of the vehicle. Det. Hendrickson said the evidence tape was cut and both driver side windows were rolled down for this viewing. When the viewing was over the windows were rolled back up and evidence tape was placed on them. I observed on 07/28/22 that the evidence tape on the driver side windows were dated 6-3-22.

JULY 28 2022:

In this viewing DA Ozanne had Investigator Pete Hanson and DDA Andrea Raymond with him. Also present were Det. Hendrickson, Deputy Greg Leatherberry, Deputy Jim Plenty and myself. DA Ozanne also requested to see the shield (TAG 44373) that is currently in evidence. The shield was transferred to me by Marci Enloe on 7/28/22. After I obtained the shield I drove to the vehicle evidence building.

Once at the vehicle evidence building Deputy Leatherberry used the bobcat to move the vehicle to the outside of the building. Once the vehicle was outside I removed the shield from the packaging. I was handed a set of keys (TAG 44380 stored at the vehicle evidence building) and I removed them from the packaging prior to rolling the back driver window down. Power was given to the vehicle via a battery pack. DA Ozanne requested someone sit inside the vehicle and I volunteered to do this. Towels were set on the seat for me due to the windows previously being broke out.

After DA Ozanne conducted his viewing the vehicle was moved back inside the vehicle evidence building and Det. Hendrickson resealed the windows with evidence tape. I placed the keys back into the evidence bag and resealed it with evidence tape then secured the keys in the key locker. I also transported the shield back to the PSB evidence room and used new packaging material and evidence tape to secure the bag on the area where I had cut it to remove the shield. I filled out the transmittal form and secured the shield and form into locker B-01.
