MOTION TO DISMISS COMPLAINT

NOW COMES the Defendant, Mark Wagner, by and through his attorneys, Michael J. Steinle and Daniel H. Sanders, upon all the records, files and proceedings heretofore had herein, respectfully moves this Honorable Court pursuant to Wis. Stats. Sec. 971.31(2) and (5) for entry of an order dismissing the complaint previously filed in this action.

AS GROUNDS THEREFORE, Counsel would show to this Court that the Court lacks jurisdiction because the Criminal Complaint by which the Defendant is charged is defective. Specifically, the complaint fails to set forth essential facts from which it could be inferred that the Defendant committed the crime charged and fails to state the essential facts constituting the crime of Second-Degree Reckless Endangering Safety contrary to Wis. Stats. Sec. 941.30(2) as required by law. Such defect is a violation of the rights guaranteed to him by the fourth, fifth and fourteenth amendments to the United States Constitution; Article 1, Sections 1, 8, and 11 of the Wisconsin Constitution; Wis. Stat. §§968.01 and 968.02; and *State v. Schneider*, 60 Wis.2d 563, 211 N.W.2d 630 (1973); *State v. Haugen*, 52 Wis.2d 791, 191 N.W.2d 12 (1971); *State ex rel. Evanow v. Seraphim*, 40 Wis.2d 223, 161 N.W.2d 369 (1968).

State v. Petrone, 161 Wis.2d 530, 418 N.W.2d 676 (1991) overruled in part on unrelated grounds by State v. Greve, 2004 WI 69, 272 Wis.2d 444, 681 N.W.2d 479.
