MEMORANDUM IN SUPPORT OF DEFENDANT'S MOTION TO RECUSE THE DANE COUNTY DISTRICT ATTORNEY

In early 2020, Special Agent (SA) of the Wisconsin Department of Justice, Division of Criminal Investigation (DCI), participated in a federal drug trafficking investigation concerning persons selling illegal narcotics in Dane County, WI, and elsewhere. During that investigation, SA learned that XXX was a large-scale cocaine trafficker in Dane County. SA initiated an investigation of XXX, his suspected customers, and his suspected source of narcotics.¹ The investigation led to state court-authorized wiretaps of telephones used by XXX to conduct drug transactions. SA worked with the Dane County District Attorney's Office (DCDAO) in the investigation and to obtain the court-authorized wiretaps.² Throughout this investigation DCDAO provided oversight,³

review, 4 charging decisions, and coordination with federal prosecutors and federal, state, and local law enforcement officers.

In early January 2021, SA, in coordination with and under the supervision of DCDAO, concluded the investigation of XXX, his drug sources, and his drug customers. The investigation revealed that XXX was a large-scale drug trafficker in the Dane County area who utilized firearms during his drug trafficking activities, had multiple drug sources, and sold large quantities of drugs to multiple individuals in the Dane County area.

During the investigation, QLW was identified as one of XXX's regular customers who bought large quantities of cocaine and was routinely in possession of firearms in drug transactions and while travelling in vehicles. At the time of the XXX investigation, QLW had an adult criminal record dating back to 2002 with several felony and misdemeanor convictions for resisting arrest/obstruction of justice, theft, disorderly conduct, operating a vehicle while revoked, escape, battery, criminal trespassing of a dwelling, intimidation of a victim, and fleeing/eluding an officer. Many of the convicted

On August 14, 2017, DCDAO filed a criminal complaint charging QLW with Possession of a Firearm by a Convicted Felon, 2nd Degree Reckless Endangering Safety, and 1st Degree Reckless Endangering Safety-Use of a Dangerous Weapon for offenses occurring on August 4, 2017. On November 1, 2017, QLW posted \$20,000 cash bail and was released with several conditions, including no contact orders, no possession of any dangerous weapon, no possession of controlled substances, and to remain in Dane County. Cash bail was posted by QLW on the two new cases and he was placed in the Dane County Monitoring Program (GPS). On July 25, 2018, QLW pled guilty to Possession of a Firearm by a Felon and 2nd Deg. RES in 2017CF1958. The 1st Deg. RES was dismissed and read in. In addition, all of the counts charged in

offenses were charged with repeater, domestic abuse, or habitual criminal modifiers.⁶ During the XXX investigation, QLW was on extended supervision with the Wisconsin Department of Corrections (WDOC) for a felony conviction in Dane Co. Case No. 2017CF1958 for Possession of a Firearm by a Felon and 2nd Degree Reckless Endangering Safety.⁷

In coordination between DCDAO and the United States Attorney's Office for the Western District of Wisconsin, six individuals identified in the XXX investigation, including one of XXX's source of drugs, were indicted in United States District Court for the Western District of Wisconsin under Case Nos. 21-CR-00020, 21-CR-34, and 21-CR-120. DCDAO agreed to charge XXX, QLW, and two others who were customers of XXX and XXX's source. To date, DCDAO has not charged any of these individuals with the drug trafficking and firearm offences committed during the XXX investigation.

Additional Information Leading up to QLW's Arrest on February 3, 2022

On August 11. 2020, 11-year-old Anisa Scott was shot and killed in Madison, WI while travelling as a passenger in a vehicle being driven by CC, the boyfriend of her mother. Madison area law enforcement, including SA, know that CC and QLW are close associates and have been suspected of committing numerous armed robberies of rival drug traffickers within the City of Madison. The investigation of AS's murder revealed that QLW and CC were being targeted by rival drug traffickers because of a previous

armed robbery of narcotics and both had a "hit" put out on them because of the robbery. The investigation also revealed that QLW was believed to be at the scene of the shooting, possibly in a separate vehicle, and may have disposed of firearms that were originally located at the scene. SA was also aware that CC was a drug associate of XXX.8

On September 3, 2020, CC was revoked from supervised release in WIWD Case No 12-CR-84 and sentenced to 21 months prison.

In early fall 2020, the Dane County Narcotics Task Force (Task Force) was investigating narcotics and firearm offenses regarding several individuals including JTM,9 QLW's brother, and others. The investigation led to the execution of a courtauthorized search warrant at QLW's family residence on Milwaukee Street in Madison. Numerous firearms were located in and seized from the residence. Subsequent to the search warrant, law enforcement learned that QLW contacted XXX about the firearms recovered by law enforcement from his family's residence. QLW said his brother was in trouble because he sold drugs to an undercover officer. QLW further stated that one of the guns belonged to his brother, JTM, and one belonged to his father. QLW was also concerned because one of the guns was connected to a crime.

On April 9, 2021, an individual, SPB, died of a drug overdose in Madison. QLW was suspected by law enforcement to be the person who sold narcotics to SPB's friend, SLB. SPB died shortly after the sale between QLW and SLB. This matter was not charged by DCDAO until February 18, 2022. According the criminal complaint, QLW was charged with Delivery of Schedule I or II Narcotics, Repeater, a Class E Felony. Law enforcement identified QLW as the drug dealer through the telephone number given to SLB, listening to jail calls between JTM and QLW, and a photo array identification by SLB as the drug dealer who sold SLB the narcotics on April 9, 2021. QLW was on extended supervision at the time of the overdose death on April 9, 2021.

On May 22, 2021, an anonymous citizen made a complaint to WDOC Probation/Parole that QLW was observed driving a vehicle, reaching under his seat to grab a black handgun and then pointing the handgun at an individual driving a bus. The complaint stated the victim in the offense did not wish to make a report because the victim feared retaliation. QLW was on extended supervision at the time of this incident.

On June 4, 2021, a criminal complaint was filed by DCDAO charging QLW with Disorderly Conduct/Domestic Violence and two days later, on June 4, 2021, DCDAO filed another criminal complaint charging QLW with Phone Threats/Domestic Violence.¹³ QLW was on extended supervision at the time of these incidents.

On June 8, 2021, members of the Dane County Narcotics Task Force (Task Force)¹⁴ attempted to take QLW in custody for the crimes described above and numerous extended supervision violations. The Task Force works with DCDAO on ongoing drug trafficking investigations and charging decisions. The Task Force, along with FBI and state DCI agents, attempted to take QLW into custody with help from aerial surveillance from the FBI. When a marked Madison Police Department squad attempted to stop QLW in his vehicle, QLW fled at a high rate of speed. During the pursuit, QLW avoided tire deflation devices and recklessly drove throughout Madison. QLW eventually stopped his vehicle in the parking lot of a window tint business, where an unknown associate of QLW's picked him up in a separate vehicle and fled the scene avoiding detection and arrest of law enforcement. DLW was on extended supervision at the time of this incident.

In late January 2022, SA met with DCDAO to plan for the arrest of QLW. DCDAO indicated state criminal charges would be filed against QLW regarding his involvement in the XXX investigation within a couple weeks of QLW's arrest.

Leading up to the anticipated arrest of QLW on February 3, 2022, DCI agents conducted extensive surveillance on QLW to determine possible arrest locations to ensure the safety of the community, the arresting officers, and QLW himself.

During the briefing of the anticipated arrest of QLW in the mid-morning hours of February 3, 2022, SA told the law enforcement participants, including DCI Special Agent

Mark Wagner, the details of QLW's arrest record, criminal history, involvement in the XXX investigation, routine possession of firearms, drug trafficking activities, involvement in the AS shooting, involvement in several uncharged shootings in Madison, and fleeing and eluding arrest from officers, including the fleeing incident on June 8, 2021.

On February 3, 2022, at approximately 7:14 am, the WDOC agent supervising QLW, in coordination with DCI and DCDAO, issued a warrant for QLW's arrest for numerous extended supervision violations and anticipated criminal charges to be filed by DCDAO.¹⁶

On February 4, 2022, SA Wagner was made aware he was formally being investigated for an officer involved shooting from the arrest of QLW on February 3, 2022.

During a court-authorized search of the vehicle driven by QLW on February 3, 2022, officers recovered forty-eight (48) grams of cocaine base (crack), twenty-three (23) grams of Fentanyl, a digital scale, \$1,856 cash, and a cellular telephone.¹⁷

On February 18, 2022, DCDAO filed a criminal complaint under Dane County Case No. 2022CF476 charging QLW with one count of Delivery of Schedule I or II Narcotics, Repeater, a Class E Felony for his role in an overdose death of SPB that occurred in Madison on April 9, 2021.¹⁸

On April 29, 2022, DCDAO filed a criminal complaint under Dane County Case No. 2022CM000831 charging QLW with one count of possession of cocaine/coca, an

unclassified misdemeanor, for the forty-eight (48) grams of crack and twenty-three (23) grams of Fentanyl found in the vehicle he was driving on February 3, 2022.¹⁹

On May 9, 2022, QLW pled guilty, pursuant to a plea agreement with DCDAO, to Delivery of Schedule I or II Narcotics without the repeater modifier in 2022CF476 and possession of cocaine/coca in 2022CM831. QLW was sentenced on the same day. DCDAO and QLW made a joint recommendation to the court for a sentence of three (3) years of initial confinement and three (3) years of extended supervision in 2022CF476 and thirty (30) days jail in 2022CM831, concurrent to each other. DCDAO also agreed to not charge QLW for any of his conduct arising out of the XXX wiretap investigation.²⁰ The court adopted the recommendation in full. The court did not address whether the sentence imposed would be concurrent or consecutive to 2017CF1958. In the absence of statute or judicial declaration to the contrary, the second sentence is presumed concurrent.²¹

Also on May 9, 2022, DCDAO moved to dismiss the domestic violence charges alleged to have occurred on June 4 and 6, 2021. The court granted the motion.²²

Lastly, to tie up all the loose ends, on May 10, 2022, QLW was finally revoked in 2017CF1958 and sent to prison for three years.

The defense in this case alleges that the Dane County District Attorney and his staff have been intimately involved in these events leading up to QLW's arrest on February 3, 2022 and the decisions regarding the same and are therefore material witnesses to be called in pretrial proceedings as well as the trial of this matter. The District Attorney and his staff have provided oversight review and all charging decisions leading up to February 3, 2022 and continues to do so to date.
