Bonita Highlands Wildfire Preparedness — Firewise Program

Dear Homeowners and Residents.

The BHHA is continuing its efforts to complete it's Firewise USA® application. Part of this effort is a comprehensive Community Wildfire Risk Assessment and 3-Year Action Plan (2026-2028). The Open Space Committee has developed a draft 3-Year Plan and is in the process of doing a review with the Board, with the hopes of submitting it by the end of the year. Our 127 acres of Open Space, including 7.5 miles of horse trails amid grasses, shrubs, Eucalyptus, and Jeffrey Pine in our Open Space remains a priority for fuel reduction activities. The 3-Year Plan includes identifying and trimming/skirting priority trees in Very High Fire Hazard Severity Zones, notifying owners of overgrown vegetation, and mulching to minimize weeds and grass in the area. Open Space Area 11, also known as Eucalyptus Grove (between Wild Oats Lane and Country Trails) is our first priority. The BHHA has received estimates to trim, remove suckling(s), and remove dead/diseased trees in this area and will be working to get this activity started as soon as possible.

Captain Jason Oosterbaan of the Bonita-Sunnyside Fire Protection District praised our efforts as "very comprehensive" and commended us for leading wildfire preparedness. He noted that, given our community's age, many soffit vents may have mesh larger than 1/8", potentially allowing embers into attics. Homeowners should check these mess vents for wear and tear. The BHHA is partnering with the Bonita-Sunnyside Fire Department to gather information on free proper-mesh soffit vents for self-installation. While affirming Open Space management, he advised balancing



resources with defensible space around homes to best minimize fire damage.

If recognized as a "Firewise" Community, the Bonita Highlands may qualify for discounts under California's Safer from Wildfires program, helping reduce or minimize anticipated upcoming homeowners' insurance rate increases. As we head into the new year, the BHHA is noticing several areas throughout the community that could use some general upkeep—particularly fences in need of repair, overgrown or dry vegetation that may pose a fire hazard, and side yards or slopes with bare dirt that should be covered with groundcover to prevent erosion. Keeping these areas maintained not only improves curb appeal but also helps protect property values and overall neighborhood safety.

We'd like to give all homeowners a friendly heads-up that the Board will be conducting more detailed, community-wide maintenance reviews in the Spring. This will include inspections of fencing, landscaping, grass, and general exterior upkeep. Taking care of any overdue maintenance now can help avoid potential compliance notices later. We appreciate everyone's effort in keeping Bonita Highlands looking its best!

Communicating with the BHHA

There are 667 homes in the BHHA and the Board and Staff Members do their best to communicate with homeowners in a timely and professional manner.

- 1. The most effective way to communicate with the BHHA is to send an email to the Recording Secretary at: bhighlanderhoa@gmail.com. She checks this email frequently and forwards them on to the appropriate BHHA Board or Staff Member for action.
- 2. Homeowners that have PayHOA accounts can use their account to communicate with the BHHA.
- 3. If a Board or Staff Member gives you another email address or phone number to use, reach out using that. But be respectful of contact information that has been given to you and DO NOT SHARE it with others without their permission.
- 4. Come to the monthly BHHA Meeting second Tuesday of every month (excluding July) at 6 p.m. at the Bonita-Sunnyside Fire Station. Homeowner issues/comments are one of the first agenda items. We recommend homeowners present a clear description of the problem as well as a suggestion for a potential solution when voicing concerns. Many homeowners choose to attend the meeting for this purpose and leave afterwards. We understand people have time constraints, but you are always welcome to stay as long as you want. If you are unable to be at the meeting at 6 p.m., show up when you can you are always welcome!

Please do not show up at Board or Staff Member's homes uninvited. If you have any issues/concerns please attend the monthly meeting or send an email as noted above.

Please be respectful in all your communications with the BHHA so that we can better assist you in finding a mutually acceptable solution to your issue or concern. We always want it to be a Win-Win Solution!
